SENATE CONCURRENT RESOLUTION NO. 559

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING "THE 2 MAGEE COURIER" FOR 100 YEARS OF RECORDING HISTORY. 3 WHEREAS, for more than 100 years, The Magee Courier has 4 recorded the events that have shaped Magee and Simpson County; and 5 WHEREAS, official state records show The Courier was founded March 19, 1899 by Will Jarvis, there is evidence that suggests a 6 7 forerunner of The Courier was published as early as 1879, but newspaper records were destroyed by fire in 1928. 8 9 WHEREAS, although the first 30 years of the paper's existence is unclear, by 1903, Ralph Gray was the paper's publisher and 10 11 Eugene Terry, editor. The name was The Magee Herald during this 12 time; and WHEREAS, in 1904, the name was changed to The Magee Courier 13 14 and that year or perhaps in 1905, W.V. Watkins was editor and publisher; and 15 16 WHEREAS, a year's subscription then cost \$1.00, and the paper was published on Friday; and 17 WHEREAS, by 1929, R.H. Watkins had become editor, and he sold 18 19 the paper to A.P. Russell in 1930; and WHEREAS, in 1936, the paper was sold to T.P. Bond. A year 20 later the trustees appointed H.D. Gillis as editor, and two months 21 later Harlan Hilburn assumed the position; Hilburn is noted as 2.2 23 being the first editor to use colored newsprint in Magee; and 24 WHEREAS, Hilburn sold to C.C. Bryant in 1939; and 25 WHEREAS, G.O. Parker bought the paper from Bryant after his retirement in 1948; Parker led The Courier from hot metal into the 26

WHEREAS, in 1970, Parker sold to Tom and Betty Dickson. They 28 29 installed the first compugraphic equipment; and WHEREAS, in late 1984, the Dicksons sold to Owen and Lacy 30 31 Lusk, who added four units to the press, and installed the paper's first computer-driven pagination and typesetting system, and when 32 the paper was sold in 1993 to Emmerick Newspaper the computers 33 34 were upgraded again; and 35 WHEREAS, The Magee Courier now employs 13 full-time and five part-time staffers; and 36 WHEREAS, The Magee Courier has been a source of historical 37 38 data for the citizens who helped build the Magee and Simpson 39 County area; and 40 WHEREAS, The Magee Courier has supported the children in their accomplishments and recognized the success of the people of 41 42 Magee in their private and business lives; and 43 WHEREAS, The Magee Courier has worked diligently for the 44 future of the City of Magee while reflecting on the past history of the citizens as they developed the area; and 45 WHEREAS, it is with great pride that we recognize this 46 47 outstanding publication for its considerable contribution to the civic and business growth of Magee and Simpson County, 48 49 Mississippi: 50 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That 51 52 we do hereby commend and congratulate "The Magee Courier" as it 53 celebrates 100 years of recording history in Magee and Simpson 54 County, Mississippi, and wish it continued success in the new 55 century.
