## SENATE CONCURRENT RESOLUTION NO. 580 (As Adopted by Senate)

- A CONCURRENT RESOLUTION COMMENDING WALTER REED UPON HIS
- 2 INDUCTION INTO THE MISSISSIPPI SPORTS HALL OF FAME.
- 3 WHEREAS, Walter Lee "Toomsuba" Reed, a distinguished athletic
- 4 administrator, coach and player who served as Athletic Director at
- 5 Jackson State University and Florida A&M, was born on September
- 6 30, 1933; and
- 7 WHEREAS, Walter Reed attended high school from 1947-1951 at
- 8 Stevenson Vocational High School in Toomsuba, Mississippi,
- 9 lettering in football and graduating with honors; and
- 10 WHEREAS, Walter Reed enrolled at Jackson State University and
- 11 lettered three years in football and track while making the
- 12 Jackson State Honor Roll, and received his Bachelor of Science
- 13 from Jackson State University in 1955, majoring in health,
- 14 physical education and recreation with a minor in social studies;
- 15 and
- 16 WHEREAS, from 1955-1959, Walter Reed served as a
- 17 teacher/coach and supervision principal at Lawrence, Mississippi,
- 18 Elementary School and later moved to Forest, Mississippi, where he
- 19 taught math and social studies and served as an athletic coach at
- 20 N.H. Pilate School; and
- 21 WHEREAS, in 1961, Walter Reed earned his master's degree in
- 22 physical education from Indiana University in Bloomington,
- 23 Indiana, and in 1965, Reed returned to his alma mater Jackson
- 24 State as an assistant football coach and head baseball coach,
- 25 leading the Tigers baseball team to its first winning season in
- 26 1966; and

- 27 WHEREAS, Walter Reed returned to East Mississippi in 1966
- 28 when he was named principal at N.H. Pilate in Newton, and from
- 29 1967-1970, was a supervisor for adult basic education in Newton
- 30 Public Schools, receiving the Newton Public Schools Student
- 31 Teacher of the Year award in 1967; and
- 32 WHEREAS, Walter Reed's career took a different twist from
- 33 1971-1973 when he worked for the Greater Miami Legal Services in
- 34 Miami, Florida, as a practice intern, while receiving his
- 35 doctorate at the Coral Gables campus of the University of Miami
- 36 with an outside major in urban studies and human relations, and an
- 37 inside major in health and phys-ed; and
- 38 WHEREAS, in 1974, Walter Reed was hired as Director of
- 39 Intramural Sports and an assistant professor of health, phys-ed
- 40 and recreation, and in 1997, was named Athletic Director at
- 41 Jackson State University; and
- WHEREAS, during Reed's tenure as athletic director, Jackson
- 43 State achieved numerous sports championships, participated in the
- 44 NCAA Division 1AA football players and hosted four of those
- 45 playoff games, and had the first historical black college women's
- 46 basketball team to participate in the NCAA Division 1A Tournament
- 47 and to host a tournament playoff game; and
- WHEREAS, in 1988, Walter Reed was named Athletic Director at
- 49 Florida A&M, where, during his six-year tenure, the FAMU sports
- 50 teams won a combined 25 MEAC titles and over two dozen athletes
- 51 were nationally ranked in NCAA Division 1 stats in baseball, men's
- 52 and women's basketball, volleyball, football and softball; and
- WHEREAS, the most noteworthy highlight of Walter's
- 54 administration skills is the fact that he never operated a deficit
- 55 program in his entire 17 years as athletic director; and
- 56 WHEREAS, Walter Reed has served on 27 professional and
- 57 charitable organizations and has made considerable contributions
- 58 to amateur athletics; and
- 59 WHEREAS, although he retired officially from athletics in

- 60 1994, Walter Reed currently serves on the Board of Directors of
- 61 the Central Mississippi Chapter for the National Football
- 62 Foundation and Hall of Fame and the All American Football
- 63 Foundation; is the chair of the Capital City Football Classic
- 64 Steering Committee and the Jackson State University Sports Hall of
- 65 Fame Club; and spends hours working as a volunteer at the
- 66 Mississippi Sports Hall of Fame and Museum; and
- 67 WHEREAS, Walter Reed is married to the former Martha
- 68 Ducksworth and they have three children, sons Clifton and Walter,
- 69 and daughter Kathy:
- 70 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 71 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 72 we do hereby congratulate and commend Walter Lee "Toomsuba" Reed
- 73 upon the occasion of his induction into the Mississippi Sports
- 74 Hall of Fame.
