SENATE CONCURRENT RESOLUTION NO. 581 (As Adopted by House and Senate)

- A CONCURRENT RESOLUTION COMMENDING JIMMIE "MISSISSIPPI RED"
- 2 MCDOWELL UPON HIS INDUCTION INTO THE MISSISSIPPI SPORTS HALL OF
- 3 FAME.
- 4 WHEREAS, Jimmie "Mississippi Red" McDowell, a storied
- 5 sportswriter from Brookhaven and the founder of the Mississippi
- 6 Sports Hall of Fame, was born on March 24, 1926; and
- 7 WHEREAS, appropriately dubbed "America's Ambassador of
- 8 Football, " Jimmie McDowell began his writing career at the tender
- 9 age of 11 when he wrote his first column entitled, "Pop Flies and
- 10 Errors, " for the old <u>Brookhaven Leader</u>; and
- 11 WHEREAS, after graduation from Brookhaven High School, Jimmie
- 12 McDowell served his country from 1944-46 in the United States Navy
- 13 Armed Guard and received an honorable discharge; and
- 14 WHEREAS, Jimmie McDowell then resumed his higher education at
- 15 Ole Miss and received his bachelor of arts degree in education in
- 16 1949; and
- 17 WHEREAS, upon graduation Jimmie McDowell quickly rose to the
- 18 position of Assistant Sports Editor at the <u>Jackson Daily News</u>, and
- 19 in 1951 was named Sports Editor of the Meridian Star; and
- WHEREAS, from 1951-55, Jimmie McDowell served as Director of
- 21 Public Relations and Athletic Publicity at the University of
- 22 Southern Mississippi in Hattiesburg, and in 1955, returned to
- 23 Jackson to accept the position of Sports Editor at the <u>Jackson</u>
- 24 <u>Daily News</u>; and
- 25 WHEREAS, in 1956, Jimmie McDowell expanded his talents to
- 26 television at WLBT-TV, where he hosted his own sports show, one of

- 27 the first ever on Mississippi television; and
- 28 WHEREAS, Jimmie McDowell moved north of the Mason-Dixon line
- 29 later in 1962 as he was named Executive Sports Editor and
- 30 columnist for the <u>Trenton Times</u> in Trenton, New Jersey, but in
- 31 1964, returned to Memphis, Tennessee, where he worked as Executive
- 32 Sports Editor and columnist for the Commercial Appeal; and
- 33 WHEREAS, in 1964, Jimmie McDowell was hired as Director of
- 34 Public Relations of the National Football Foundation and Hall of
- 35 Fame, and six years later in 1970, was appointed executive
- 36 director of the organization; and
- 37 WHEREAS, from 1964 until his retirement in 1991, Jimmie
- 38 McDowell would serve the NFFHOF as Chief Administrative Officer,
- 39 overall administrator of national chapters, Chief Fundraiser,
- 40 editor of all foundation publications, and a key organizer of the
- 41 Hall of Fame Bowl played originally in Birmingham, Alabama, and
- 42 now located in Tampa, Florida; and
- WHEREAS, after his retirement from the NFFHOF, Jimmie
- 44 McDowell was named as Director of Corporate Development of the
- 45 Liberty Bowl in Memphis and also remained active as a consultant
- 46 with the NFFHOF and for the Ole Miss Loyalty Foundation, the
- 47 fundraising wing of the Rebel athletics; and
- WHEREAS, feeling the itch to do even more for the sport of
- 49 college football, Jimmie McDowell formed the All American Football
- 50 Foundation in 1994, a non-profit organization which hosts a
- 51 Banquet of Champions and selects an All American Team after the
- 52 college season is completed; and
- WHEREAS, as of March 1, 1998, there are 129 collegiate
- 54 members of the All American Football Foundation; and
- 55 WHEREAS, named Outstanding Mississippian of the Year in 1973,
- 56 Jimmie McDowell has received a cavalcade of awards and honors for
- 57 his support and relentless promotion of the sport of college
- 58 athletics; and
- 59 WHEREAS, Jimmie McDowell, a resident of Jackson, still

- 60 remains active in sportswriting as he has been a freelance
- 61 columnist for 10 newspapers in Mississippi since 1991:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 63 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 64 we do hereby congratulate and commend Jimmie "Mississippi Red"
- 65 McDowell upon the occasion of his induction into the Mississippi
- 66 Sports Hall of Fame.
