SENATE CONCURRENT RESOLUTION NO. 582 (As Adopted by House and Senate)

1 2	A CONCURRENT RESOLUTION COMMENDING JAMES HAROL LOFTON UPON HIS POSTHUMOUS INDUCTION INTO THE MISSISSIPPI SPORTS HALL OF FAME.
3	WHEREAS, James Harol Lofton, a superbly talented athlete who

played halfback and fullback for Ole Miss in the early 1950's, was

- 5 born on February 14, 1931; and
- 6 WHEREAS, James Harol Lofton was a native of Brookhaven and an
- 7 acclaimed high school athlete at Brookhaven High School, starting
- 8 his celebrated high school career at the age of 14 and earning a
- 9 remarkable 15 letters in football, track, baseball and basketball;
- 10 and

- 11 WHEREAS, after his senior year in high school, James Harol
- 12 Lofton was named as the Big Eight's Most Valuable Football Player
- 13 and was Mississippi's No. 1 prep star, and following these honors,
- 14 the Touchdown Club in Brookhaven passed a resolution requesting
- 15 that the school board retire Lofton's No. 19 red and blue jersey;
- 16 and
- 17 WHEREAS, upon graduation from Brookhaven, James Harol Lofton
- 18 was actively recruited by 22 colleges, including teams from as far
- 19 west as Oregon State and Colorado; and
- 20 WHEREAS, James Harol Lofton signed with Ole Miss, earning 3
- 21 letters in 1951, 1952 and 1953 while playing halfback and fullback
- 22 for Head Coach Johnny Vaught; and
- 23 WHEREAS, Lofton scored 8 touchdowns for Ole Miss in 1952 and
- 24 ran for 24 yards in the 1953 Sugar Bowl loss to Georgia Tech; and
- 25 WHEREAS, in 1953, Lofton achieved All SEC status as he ran
- 26 219 yards with 4 scores, averaging 6.0 yards a carry, and caught

- 27 10 passes for 180 yards and a touchdown; and
- 28 WHEREAS, during his Ole Miss career, James Harol Lofton had
- 29 979 rushing yards, scored 12 touchdowns, averaged 5.15 yards per
- 30 rush, was one of 5 famous Ole Miss backs to average 5 yards a
- 31 carry, was tied for 6th place with 3 touchdowns for scoring in a
- 32 single game, and was 16th in career punting; and
- 33 WHEREAS, married in 1954 to the former Salena Smith from his
- 34 hometown, James Harol Lofton joined the U.S. Army and played
- 35 service football from 1955 through 1957 while stationed at Fort
- 36 Bliss, Texas; and
- 37 WHEREAS, in 1957, Lofton returned home to Brookhaven and
- 38 operated Lofton's Hereford Farms, and in 1962, rejoined the Army
- 39 as a captain and served at Fort Bragg, North Carolina, in military
- 40 intelligence; and
- 41 WHEREAS, after his military service was concluded, James
- 42 Harol Lofton returned to Mississippi in 1967, where he owned and
- 43 operated Lofton Oil Products, a Gulf Oil distributor; and
- WHEREAS, in 1978, Lofton was critically injured when a
- 45 150-foot tree fell on him, never recovering physically from the
- 46 timber accident; and
- 47 WHEREAS, James Harol Lofton was diagnosed with cancer on
- 48 March 31, 1981, and passed away months later on June 17, 1981, at
- 49 the age of 50; and
- 50 WHEREAS, Lofton devoted countless hours as a Scout leader in
- 51 the Boy Scouts, and as a deacon, Sunday School teacher and a
- 52 member of the choir of the First Baptist Church of Brookhaven; and
- 53 WHEREAS, Harol and Salena Lofton had four children, Mindy L.
- 54 Tew, James Harol Lofton, Jr., John Carol Lofton and Joel Robert
- 55 Lofton:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 57 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 58 we do hereby congratulate and commend James Harol Lofton upon the
- 59 occasion of his posthumous induction into the Mississippi Sports

- 60 Hall of Fame.
