- 4 of the Mississippi Senate in order to seek the Democratic

- 7 of tireless service and commitment to the 52 Senators who serve in
- 8 the Mississippi Senate; and
- 9 WHEREAS, in the Senate's top administrative job since January
- 10 1996, Amy Tuck has effectively supervised staff and overseen
- 11 day-to-day operations of the agency; and
- 12 WHEREAS, prior to her appointment as Secretary of the Senate,
- 13 Amy Tuck served as a state Senator from 1991 to 1996, representing
- 14 the citizens of Choctaw, Montgomery, Oktibbeha and Webster
- 15 Counties; and
- 16 WHEREAS, Amy Tuck's tenure as a state Senator is noted by her
- 17 appointment as Chairman of the County Affairs Committee
- 18 (1992-1996), and her earnest involvement in the passage of a bill
- 19 to establish a county bridge replacement and repair program; and
- 20 WHEREAS, in 1995, Amy Tuck chose not to seek re-election as a
- 21 state Senator, opting instead to run for Secretary of State; and
- WHEREAS, during the February 4, 1999, Senators' reunion
- 23 ceremony, Amy Tuck was voted to receive the 1999 Senate
- 24 Distinguished Service Award by ballot of all present and former
- 25 members of the Senate; and
- 26 WHEREAS, she is well known for her common sense, good nature

- 27 and irrepressible sense of humor, all of which will be missed by
- 28 her colleagues; and
- 29 WHEREAS, Amy Tuck has distinguished herself as a highly
- 30 respected administrator and has served in a manner which will be
- 31 an exceptional model for her successors to emulate; and
- 32 WHEREAS, it is the policy of the Legislature to commend the
- 33 exemplary service of the citizens of this state:
