- 4 WHEREAS, Jackson, Mississippi-based Miskelly Furniture has
- 5 received the Tupelo Furniture Market's Fall 1998 Buyer
- 6 Appreciation Award; and
- WHEREAS, the buyer award is given twice a year by the Tupelo
- 8 Furniture Marketing Association to recognize retailers who have
- 9 consistently supported the Mississippi furniture industry and the
- 10 Tupelo Furniture Market; and
- 11 WHEREAS, the Miskelly brothers, Chip, Oscar and Tommy, opened
- 12 their first 8,000-square-foot store east of Jackson in 1978, and
- 13 since then, the company has grown to operate two stores in central
- 14 Mississippi; and
- WHEREAS, the main store in Jackson is 70,000 square feet,
- 16 while the Howard Miskelly Furniture Clearance Center is 25,000
- 17 square feet, and future plans include the completion of a
- 18 150,000-square-foot distribution center and construction of a new
- 19 50,000-square-foot store in North Jackson; and
- WHEREAS, having grown up in Okolona, Mississippi, a few miles
- 21 south of Tupelo, the Miskelly brothers first got the idea for
- 22 their retail stores by watching the Tupelo area spring to life
- 23 with furniture manufacturing plants and watching those plants
- 24 spawn discount retail outlets; and
- 25 WHEREAS, 1998 marked the first year Miskelly Furniture was
- 26 ranked on Furniture/Today's list of Top 100 U.S. Furniture Stores,

- 27 at number 93 with 1997 sales of \$34.2 Million; and
- WHEREAS, Miskelly Furniture has become the leading furniture
- 29 retailer in the Jackson, Mississippi, market and surrounding area,
- 30 enjoying an average sales growth of nearly 25% a year since
- 31 opening in 1978; and
- 32 WHEREAS, always staying true to their word, the Miskelly
- 33 brothers have found success by cultivating the foundation of the
- 34 family business in trusting relationships with vendors, employees,
- 35 customers and God; and
