SENATE CONCURRENT RESOLUTION NO. 647  
(As Adopted by Senate)

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE  
2 PURPOSE OF THE FURTHER CONSIDERATION AND PASSAGE OF HOUSE BILL NO.  
3 700, 1999 REGULAR SESSION, ENTITLED "AN ACT TO AMEND SECTION  
4 17-3-9, MISSISSIPPI CODE OF 1972, TO EXPAND THE LIST OF  
5 MUNICIPALITIES THAT MAY ACQUIRE AND USE LAND AND OTHER PROPERTY  
6 FOR CONVENTION CENTERS; TO AMEND SECTION 17-3-11, MISSISSIPPI CODE  
7 OF 1972, TO PROVIDE THAT IF A MUNICIPALITY LEASES CONVENTION  
8 CENTER FACILITIES AND PROPERTY TO CERTAIN ENTITIES, THE  
9 MUNICIPALITY MAY TRANSFER THE FACILITIES AND PROPERTY TO THE  
10 ENTITIES FOR A NOMINAL CONSIDERATION AT THE END OF THE LEASE  
11 PERIOD; TO PROVIDE THAT THE DEED OR OTHER INSTRUMENT OF CONVEYANCE  
12 OF THE FACILITIES AND PROPERTY SHALL CONTAIN A REVERTER CLAUSE; TO  
13 AMEND SECTION 21-17-1, MISSISSIPPI CODE OF 1972, IN CONFORMITY  
14 WITH THE PRECEDING PROVISION; AND FOR RELATED PURPOSES."

15 BE IT RESOLVED BY THE SENATE OF THE STATE OF MISSISSIPPI, THE  
16 HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That the following  
17 bill is hereby exempt from the timetable for consideration of  
18 bills provided by Joint Rule No. 40, and that consent is hereby  
19 given for further consideration of House Bill No. 700, 1999  
20 Regular Session, entitled "AN ACT TO AMEND SECTION 17-3-9,  
21 MISSISSIPPI CODE OF 1972, TO EXPAND THE LIST OF MUNICIPALITIES  
22 THAT MAY ACQUIRE AND USE LAND AND OTHER PROPERTY FOR CONVENTION  
23 CENTERS; TO AMEND SECTION 17-3-11, MISSISSIPPI CODE OF 1972, TO  
24 PROVIDE THAT IF A MUNICIPALITY LEASES CONVENTION CENTER FACILITIES  
25 AND PROPERTY TO CERTAIN ENTITIES, THE MUNICIPALITY MAY TRANSFER  
26 THE FACILITIES AND PROPERTY TO THE ENTITIES FOR A NOMINAL  
27 CONSIDERATION AT THE END OF THE LEASE PERIOD; TO PROVIDE THAT THE  
28 DEED OR OTHER INSTRUMENT OF CONVEYANCE OF THE FACILITIES AND  
29 PROPERTY SHALL CONTAIN A REVERTER CLAUSE; TO AMEND SECTION  
30 21-17-1, MISSISSIPPI CODE OF 1972, IN CONFORMITY WITH THE  
31 PRECEDING PROVISION; AND FOR RELATED PURPOSES."
