- 4 WHEREAS, Dr. James Earl Lyons, Sr., President of Jackson
- 5 State University, is stepping down from office to assume the
- 6 presidency of another institution; and
- 7 WHEREAS, Dr. James Earl Lyons, Sr. assumed the presidency of
- 8 Jackson State University on July 1, 1992; he became the eighth
- 9 president of Mississippi's fourth largest institution of higher
- 10 learning and one of the nation's premier Historically Black
- 11 Colleges and Universities (HBCUs); and
- 12 WHEREAS, Lyons brought to Jackson State a proven track record
- 13 of rallying businessmen, city and county officials and community
- 14 leaders behind the goals of a university; since arriving at
- 15 Jackson State, he has been able to attract support from all
- 16 segments of the community and collectively, they have recognized
- 17 the need for developing Jackson State University as the Urban
- 18 University of Mississippi and developing the West Jackson
- 19 community; and
- 20 WHEREAS, one of the most important steps in that direction
- 21 has been Lyons' development of a Campus Master Plan that projects
- 22 the growth of the university well into the 21st Century; land and
- 23 other property have been secured for growth and revitalization of
- 24 the area around the campus; a \$16 million home for the School of
- 25 Liberal Arts, the first of several new buildings envisioned in the
- 26 Campus Master Plan, is in the final planning stages; also underway

27 is a $12 million expansion of the H.T. Sampson Library, an effort
```

28 which will nearly double the library's existing size; all of the

- 29 growth and expansion under Lyons' leadership are not occurring
- 30 within the confines of the campus. Overwhelming support of a
- 31 proposed parkway, an extensive boulevard which will link Jackson
- 32 State to the downtown business district and greatly improve West
- 33 Jackson, has been received from city, county, state and federal
- 34 officials; and
- WHEREAS, under Lyons' leadership, Jackson State moves
- 36 confidently toward the future as a major force in the region and
- 37 among its peer institutions; additional graduate and undergraduate
- 38 programs have been implemented; namely, the Ph.D. in Clinical
- 39 Psychology and the B.S. in Child Care and Family Education; along
- 40 with the Council on Social Work Education's approval of candidacy
- 41 status for the master's degree in social work program, these
- 42 degree programs clearly emphasize Jackson State's role in
- 43 providing programs that seek solutions to urban problems in the
- 44 physical, social, intellectual and economic environments;
- 45 additional achievements in the academic realms include the
- 46 selection of Jackson State University as a contender in the
- 47 National Science Foundation's Minority Institution of Excellence
- 48 (MIE) program; the identification of Jackson State as the sole
- 49 HBCU with a Reading Recovery Program, an intervention program for
- 50 "at risk" first grade students; and the completion of the process
- 51 for acquiring accreditation of the Jackson State University School
- 52 of Business; and
- 53 WHEREAS, prior to assuming the presidency of Jackson State
- 54 University, Lyons served as President of Bowie State University
- 55 (Maryland) for nine years (1983-1992); other administrative posts
- 56 include Vice-President and Dean of Academic Affairs, Chief
- 57 Negotiator and Professor of Education at Delaware State College in
- 58 Dover, Delaware, from 1978 to 1983; Vice-President for Academic
- 59 Affairs and Professor of Education at Barber-Scotia College,
- 60 Concord, North Carolina, from 1975 to 1978; Assistant to the
- 61 Vice-Chancellor for Academic Affairs and Director of Summer School
- 62 at Fayetteville State University, Fayetteville, North Carolina
- 63 from 1974 to 1975; administrative assistant to the Vice-President

- 64 for Academic Affairs, Director of Institutional Research and as
- 65 Social Professor of Education at Kentucky State University,
- 66 Frankfort, Kentucky, from 1973 to 1974; Assistant Dean of
- 67 Students, Director of the Afro-American Cultural Center, Black
- 68 Student Advisor, University of Connecticut, Storrs, Connecticut,
- 69 from 1969 to 1973; instructor of Afro-American Studies at Central
- 70 Connecticut State College, New Britain, Connecticut; and Director
- 71 of the Conscience Educational Day Camp of Temple University, North
- 72 Philadelphia, Pennsylvania, from 1967 to 1969; and
- 73 WHEREAS, Lyons also worked as a Peace Corps volunteer in
- 74 Ecuador during the late 1960s and as a tutor-counselor with the
- 75 Rodman Job Corps in New Bedford, Massachusetts; and
- 76 WHEREAS, a native of New Haven, Connecticut, Lyons holds
- 77 degrees from the University of Connecticut (B.A., Spanish, 1965;
- 78 M.A., Student Personnel, 1971; Ph.D., Professional Higher
- 79 Education, 1973) and has done post-doctoral study at the Harvard
- 80 University Institute for Educational Management; Lyons serves on
- 81 the board of directors of a number of organizations including the
- 82 American Association of State Colleges and Universities (AASCU),
- 83 the National Association for Equal Opportunity in Higher Education
- 84 (NAFEO), Institute for Technology Development (ITD), Basic
- 85 Technologies International (BTI) and Capitol City, Incorporated.
- 86 He is a reviewer on the Objective Review Committee which evaluates
- 87 grants for the Division of Programs for Special Populations,
- 88 Department of Health and Human Services and has also served as a
- 89 member of the editorial board of the Educational Record; he is the
- 90 Public University Representative to the Board of Directors,
- 91 Mississippi Association of Colleges (MAC), President of the
- 92 Council of Presidents, Southwestern Athletic Conference (SWAC) and
- 93 serves on the Hall of Fame Committee of the Mississippi Press
- 94 Association and the Information Resource Council of the
- 95 Mississippi Central Data Processing Authority; a widely published
- 96 author, Lyons has written articles on subjects ranging from the

- 97 United States Constitution to integration and race relations. His
- 98 works have appeared in such publications as the Educational
- 99 Record, the Howard Law Review, The Journal of Negro Education,
- 100 Today's Education, Essence Magazine and World View, a publication
- 101 of the American Association of State Colleges and Universities'
- 102 Office of International Programs; he has made numerous appearances
- 103 before school, community and professional groups and has appeared
- 104 before Congress a number of times as a spokesman for such groups
- 105 as ACE, AASCU and NAFEO. He has served as the lead person in
- 106 AASCU's Delegation of Presidents to Mexico and has judged The
- 107 Clarion-Ledger's All-Star Seniors Competition; Lyons is a member
- 108 of numerous organizations, including the Office for the
- 109 Advancement of Public Black Colleges, the National Association of
- 110 State Universities and Land Grant Colleges (NASULGC); the American
- 111 Association of Colleges for Teacher Education (AACTE); Phi Delta
- 112 Kappa; Phi Kappa Phi; Pi Lambda Theta; 100 Black Men of Jackson,
- 113 Inc.; Information Resource Council, Mississippi Central Data
- 114 Processing Authority (CDPA); Omega Psi Phi Fraternity, Inc.; and
- 115 Sigma Pi Phi Fraternity, Inc., Beta Mu Boule; and
- 116 WHEREAS, Lyons is married to the former Jocelyn Massie and is
- 117 the father of three sons; and
- 118 WHEREAS, it is with great pride that we recognize the service
- 119 of this individual who has brought pride to Jackson State
- 120 University, the City of Jackson and to the State of Mississippi:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 122 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 123 we do hereby commend Jackson State University President James E.
- 124 Lyons, Sr., upon the occasion of his retirement from office, and
- 125 wish him and his family continued success in his future career
- 126 endeavors.

- 128 Dr. Lyons and his family and be made available to the Capitol
