SENATE CONCURRENT RESOLUTION NO. 660
(As Adopted by House and Senate)

1 A CONCURRENT RESOLUTION COMMENDING BOB HUTSON FOR HIS SERVICE
2 ON THE COMMISSION ON ENVIRONMENTAL QUALITY AND FOR HIS EFFORTS IN
3 NATURAL RESOURCES CONSERVATION AND ENVIRONMENTAL PROTECTION.

4 WHEREAS, Governor Kirk Fordice appointed Bob Hutson to serve
5 on the Commission on Environmental Quality in 1993; and

6 WHEREAS, in July, 1998, Bob Hutson was elected as the
7 Chairman of the Commission on Environmental Quality and will
8 conclude his service in that position in June, 1999; and

9 WHEREAS, prior to his service on the Commission on
10 Environmental Quality, he served as Director of the Natural and
11 Environmental Resources Division for the Mississippi Farm Bureau
12 Federation for twenty-four years and also served as Director of
13 Information Division of Farm Bureau; and

14 WHEREAS, he was a key participant in the development of
15 programs for the disposal of waste pesticide containers and waste
16 pesticides and for water quality testing in rural private drinking
17 water wells; and

18 WHEREAS, Mr. Hutson has advised the Legislature on numerous
19 environmental protection and natural resource issues, particularly
20 with regard to their impact on Mississippi agriculture; and

21 WHEREAS, Bob currently serves as a member of the Mississippi
22 Water Resources Advisory Council and the Pearl River Basin
23 Development District Board of Directors and has served on several
24 water resources management planning efforts in the past; and

25 WHEREAS, he has been recognized for his efforts in the
26 establishment of joint water management districts in the

27 Yazoo-Mississippi Delta and in the Pearl River Basin; and

28 WHEREAS, he has served on numerous regional and national
29 advisory committees on environmental protection and natural
30 resource issues and has served as a guest speaker and lecturer on
31 those issues at community colleges and universities in the state;
32 and

33 WHEREAS, Mr. Hutson served in the United States Army and
34 retired from military service in 1986 as a Lieutenant Colonel; and

35 WHEREAS, Bob Hutson is married to Sarah Lyle Hutson, who has
36 been active and supported him in his efforts; and

37 WHEREAS, it is the policy of this Legislature to recognize
38 and commend the exemplary service of the citizens of this state:

39 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
40 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
41 we do hereby commend Bob Hutson on his distinguished service and
42 tireless dedication as a member and Chairman of the Commission on
43 Environmental Quality and for his many efforts in natural
44 resources conservation and environmental protection and wish him
45 success in his future endeavors.
