## SENATE CONCURRENT RESOLUTION NO. 663 (As Adopted by House and Senate)

A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE 1 2 PURPOSE OF THE FURTHER CONSIDERATION AND PASSAGE OF HOUSE BILL NO. 3 530, 1999 REGULAR SESSION, ENTITLED "AN ACT TO CREATE THE 4 MISSISSIPPI SINGLE FAMILY RESIDENTIAL HOUSING FUND; TO PROVIDE 5 THAT THE MISSISSIPPI DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT SHALL ADMINISTER SUCH FUND AS A REVOLVING FUND FOR THE PURPOSE OF MAKING LOANS TO ASSIST IN THE CONSTRUCTION OR б 7 REHABILITATION, OR BOTH, OF SINGLE FAMILY RESIDENTIAL HOUSING FOR 8 9 PERSONS OF LOW OR MODERATE INCOME; TO AUTHORIZE THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE STATE OF MISSISSIPPI IN THE AMOUNT 10 11 OF FIVE MILLION DOLLARS TO FUND THE MISSISSIPPI SINGLE FAMILY RESIDENTIAL HOUSING FUND; AND FOR RELATED PURPOSES.' 12

13 BE IT RESOLVED BY THE SENATE OF THE STATE OF MISSISSIPPI, THE 14 HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That the following bill is hereby exempt from the timetable for consideration of 15 16 bills provided by Joint Rule No. 40, and that consent is hereby given for further consideration of House Bill No. 530, 1999 17 Regular Session, entitled "AN ACT TO CREATE THE MISSISSIPPI SINGLE 18 19 FAMILY RESIDENTIAL HOUSING FUND; TO PROVIDE THAT THE MISSISSIPPI 20 DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT SHALL ADMINISTER 21 SUCH FUND AS A REVOLVING FUND FOR THE PURPOSE OF MAKING LOANS TO ASSIST IN THE CONSTRUCTION OR REHABILITATION, OR BOTH, OF SINGLE 2.2 FAMILY RESIDENTIAL HOUSING FOR PERSONS OF LOW OR MODERATE INCOME; 23 24 TO AUTHORIZE THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE STATE 25 OF MISSISSIPPI IN THE AMOUNT OF FIVE MILLION DOLLARS TO FUND THE 26 MISSISSIPPI SINGLE FAMILY RESIDENTIAL HOUSING FUND; AND FOR 27 RELATED PURPOSES."
