- 3 ACTIONS TO TRAIN AND EMPLOY WELFARE RECIPIENTS IN STATE JOBS TO
- 4 THE FULLEST EXTENT POSSIBLE.
- 5 WHEREAS, national welfare reform became a reality on
- 6 August 22, 1996, when President Clinton signed the Personal
- 7 Responsibility and Work Opportunity Reconciliation Act of 1996
- 8 that Congress had passed earlier that year; and
- 9 WHEREAS, during the 1997 Regular Session, the Mississippi
- 10 Legislature enacted a bill to implement the federal welfare reform
- 11 law in this state and the Governor signed the bill on March 12,
- 12 1997; and
- 13 WHEREAS, the federal welfare reform law replaced the Aid to
- 14 Families with Dependent Children (AFDC) program with the Temporary
- 15 Assistance for Needy Families (TANF) program, which provides block
- 16 grants to states to provide time-limited cash assistance to needy
- 17 families; and
- 18 WHEREAS, one of the main purposes of the federal welfare law
- 19 is to require able-bodied TANF recipients to participate in work
- 20 activities for a certain number of hours per week after they have
- 21 received TANF benefits for 24 months, and each state must meet
- 22 minimum work participation rates for the state's TANF caseload or
- 23 the state will be sanctioned; and
- 24 WHEREAS, many jobs will have to be made available for TANF
- 25 recipients in order for the recipients and the state to meet the
- 26 work requirements of the federal law, and while the private sector
- 27 is expected to provide a majority of those jobs, the public sector

- 28 also will need to make a number of jobs available if there are to
- 29 be enough jobs for TANF recipients and the states to meet the work
- 30 requirements; and
- 31 WHEREAS, on March 8, 1997, President Clinton announced that
- 32 the federal government, which is America's largest employer, will
- 33 do its part and set an example in hiring welfare recipients, and
- 34 issued a directive to the heads of all federal agencies and
- 35 departments telling them "to use all available hiring
- 36 authorities...to hire people off the welfare rolls into available
- 37 jobs in government"; and
- 38 WHEREAS, Mississippi's just-enacted welfare reform law
- 39 requires the Department of Human Services to enter an agreement
- 40 with the State Personnel Board and other state agencies that will
- 41 allow TANF recipients who qualify for vacant jobs within state
- 42 agencies to be placed in state jobs; and
- WHEREAS, the State of Mississippi should lead the way in
- 44 hiring TANF recipients and be an example to the private sector,
- 45 and should not expect the private sector to provide jobs for TANF
- 46 recipients if the state itself does not do so:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 48 MISSISSIPPI, That we strongly encourage the Governor, the State
- 49 Personnel Board and all other state agencies and departments to
- 50 take all necessary actions to train and employ TANF recipients in
- 51 state jobs to the fullest extent possible.
- BE IT FURTHER RESOLVED, That copies of this resolution be
- 53 furnished to the Governor and to the State Personnel Board, which
- 54 shall provide copies of this resolution to the head of each state
- 55 agency and department.
