SENATE RESOLUTION NO. 5

1 A RESOLUTION COMMENDING CLARA NELL MANCIL FOR SERVICE TO HER
2 COMMUNITY AND PROFESSION, AND CONGRATULATING HER UPON THE OCCASION
3 OF HER RETIREMENT.

4 WHEREAS, Clara Nell Mancil is retiring after a 46-year career
5 in banking; and

6 WHEREAS, Clara Nell Mancil has served as the local banker in
7 Richland for the past 34 years; and

8 WHEREAS, Clara Nell Mancil's banking expertise and rapport
9 with the people of the community has earned her the trust and
10 respect of the people in her community; and

11 WHEREAS, Clara Nell Mancil has risen through the ranks to
12 become First Vice-President and Manager of the Richland Branch of
13 Trustmark National Bank in the City of Richland; and

14 WHEREAS, Clara Nell Mancil began her career in banking with
15 the Deposit Guaranty National Bank in 1952; and

16 WHEREAS, Clara Nell Mancil served with First Mississippi
17 National Bank from 1965 to 1979; and

18 WHEREAS, Clara Nell Mancil has served at Trustmark National
19 Bank since 1979; and

20 WHEREAS, Clara Nell Mancil will end her service in the
21 banking community on February 26, 1999, when she will retire; and

22 WHEREAS, Clara Nell Mancil's commitment to her community is
23 evidenced by her service to numerous charitable and service
24 organizations in which she has held positions of leadership; and

25 WHEREAS, in recognition of her business acumen, Clara Nell
26 Mancil has served in a variety of positions on the Richland

27 Economic Development Association, the Richland Water and Sewer
28 District, the Rankin County Chamber of Commerce and the Financial
29 Women International (FWI); and

30 WHEREAS, Clara Nell Mancil has also served as a Director of
31 the Rankin County Cancer Society, County Treasurer and Community
32 Chairman of the Rankin County Heart Association and Section
33 Chairman for the United Way; and

34 WHEREAS, Clara Nell Mancil is committed to improving the
35 education of the children of her community serving as President,
36 Vice-President and Treasurer of the Richland School PTA and the
37 Rankin Academy Patrons League; and

38 WHEREAS, Clara Nell Mancil is an active and dedicated member
39 of the Richland United Methodist Church where she has served as a
40 Sunday School teacher and as Secretary to the Administrative
41 Board; and

42 WHEREAS, she is married to William Carl (Billy) Mancil and
43 they have two children, Sherri Mancil and Scot Mancil, and two
44 grandchildren; and

45 WHEREAS, it is the policy of the Mississippi Senate to
46 commend the dedicated service of the citizens of the state:
