- 19 14 years as an accountant at Alcorn State University, where he was
- 20 ultimately promoted to the position of purchasing agent; and
- 21 WHEREAS, in January of 1988, Frank Wilson was sworn in as the
- 22 first male African-American Chancery Clerk of Claiborne County
- 23 since Reconstruction; and
- WHEREAS, he was reelected in 1991 and 1995; and
- 25 WHEREAS, he is a member and trustee of St. Peter AME Church
- 26 in Port Gibson, a member of Alpha Phi Alpha Fraternity, Inc., has

- 27 served as Treasurer of Theta Sigma Lambda Chapter, Alcorn State
- 28 University and is currently President of Lambda Chapter of Alpha
- 29 Phi Alpha Fraternity; and
- 30 WHEREAS, the husband of Pearl Myers Wilson, he is also the
- 31 proud father of Wevly, Weslynne and Warren; and
- 32 WHEREAS, Frank M. Wilson has served the citizens of Claiborne
- 33 County both faithfully and well in his years as their Chancery
