- 4 Officer of The Taylor Group, Inc., in Louisville, Mississippi, was
- 5 recently selected for induction into the Mississippi Business Hall
- 6 of Fame; and
- 7 WHEREAS, W.A. "Bill" Taylor was chosen not only because of
- 8 his accomplishments in the business world, but also because of his
- 9 contributions to his community and state; and
- 10 WHEREAS, he joins other laureates who have been inducted into
- 11 the Mississippi Business Hall of Fame since its founding in 1989
- 12 by Junior Achievement of Mississippi and its co-sponsor, The
- 13 <u>Clarion-Ledger</u>; and
- 14 WHEREAS, a 17-person selection committee, composed of
- 15 business leaders and educators from across the state, chose Taylor
- 16 from over 100 nominations submitted statewide; and
- 17 WHEREAS, W.A. "Bill" Taylor has been Chairman and CEO of The
- 18 Taylor Group, originally Taylor Machine Works, since 1968; and
- 19 WHEREAS, a native of Winston County, W.A. "Bill" Taylor
- 20 attended Mississippi College and Mississippi State University; and
- 21 WHEREAS, Taylor's father, W.A. "Alec" Taylor, founded Taylor
- 22 Machine Works in 1927 as an automotive and repairs business, and
- 23 in 1937, built the first timber skidder; and
- 24 WHEREAS, the company later began making forklift trucks and
- 25 has diversified over the years, the latest division of which
- 26 rebuilds locomotives; and

- 27 WHEREAS, The Taylor Group is the largest privately owned
- 28 maker of lift trucks in the country and one of the largest in the
- 29 world; and
- 30 WHEREAS, Taylor is widely known for his collection of antique
- 31 fire trucks and Western art, both passions he displays in museums
- 32 open to the public; and
- 33 WHEREAS, it is the policy of this Legislature to commend and
- 34 recognize the exemplary service of its citizens:
