REPORT OF CONFERENCE COMMITTEE

MR. PRESIDENT AND MR. SPEAKER:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S.B. No. 2303: Per diem; Supreme Court and Court of Appeals Judges, Public Service and Transportation Commissioners.

We, therefore, respectfully submit the following report and recommendation:

- 1. That the House recede from its Amendment No. 1.
- 2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 9 SECTION 1. Section 25-3-43, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 25-3-43. (1) When any chancery judge, county judge or
- 12 circuit judge shall be required to travel in the performance of
- 13 his official duties, such judge shall receive as expenses of such
- 14 travel the mileage allowance and a reimbursement for other actual
- 15 and necessary expenses incurred in such travel as provided for
- 16 public officers and employees in Section 25-3-41, Mississippi Code
- 17 of 1972. This shall be the entire travel allowances or travel
- 18 expenses received by such judges.
- 19 (2) Chancery judges and circuit judges shall direct requests
- 20 for reimbursement for the travel expenses authorized pursuant to
- 21 this section to the Supreme Court and the Supreme Court shall
- 22 submit such requests to the Department of Finance and
- 23 Administration.
- 24 (3) The Supreme Court shall have the power to adopt rules
- 25 and regulations regarding the administration of travel expenses
- 26 authorized pursuant to this section.
- 27 (4) In any county in which is located a State Penitentiary,
- 28 the board of supervisors, in order to compensate the justice court
- 29 judges who are required to travel to the State Penitentiary, is
- 30 authorized to reimburse justice court judges' mileage in the
- 31 amount authorized by Section 25-3-41, but not to exceed One

- 32 Hundred Dollars (\$100.00) per month, such monies to be paid from
- 33 the general county fund of such county.
- 34 (5) In addition to the regular salary provided by Section
- 35 <u>25-3-35</u> and the mileage reimbursement provided by Section 25-3-41,
- 36 <u>each Supreme Court Justice and each judge of the Court of Appeals</u>
- 37 <u>shall receive an expense allowance as specified in this</u>
- 38 <u>subsection</u>. The expense allowance shall be equal to the maximum
- 39 <u>daily expense rate allowable to employees of the federal</u>
- 40 government for travel in the high rate geographical area of
- 41 Jackson, Mississippi, as may be established by federal
- 42 regulations, per day, for each day while actually attending to
- 43 judicial duties in Jackson, Mississippi, not to exceed twenty (20)
- 44 <u>days per month.</u>
- 45 SECTION 2. Section 9-4-13, Mississippi Code of 1972, is
- 46 amended as follows:
- 47 9-4-13. (1) The judges of the Court of Appeals shall
- 48 receive salaries as provided for in Section 25-3-35, shall be
- 49 reimbursed for <u>mileage</u> expenses incurred in performing their
- 50 duties at the rate authorized by law for public officials and
- 51 employees as provided for in Section 25-3-41, and shall receive an
- 52 <u>expense allowance as provided for in Section 25-3-43</u>.
- 53 (2) Staff attorneys, law clerks and all other employees of
- 54 the Court of Appeals shall be of the same grade classification as
- 55 Supreme Court employees performing the same or similar duties.
- SECTION 3. The Attorney General of the State of Mississippi
- 57 shall submit this act, immediately upon approval by the Governor,
- or upon approval by the Legislature subsequent to a veto, to the
- 59 Attorney General of the United States or to the United States
- 60 District Court for the District of Columbia in accordance with the
- 61 provisions of the Voting Rights Act of 1965, as amended and
- 62 extended.
- 63 SECTION 4. This act shall take effect and be in force from
- 64 and after July 1, 1999, or the date it is effectuated under
- 65 Section 5 of the Voting Rights Act of 1965, as amended and
- 66 extended, whichever date is later.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:
