Pending AMENDMENT No. 1 PROPOSED TO

House Bill NO. 452

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

6 SECTION 1. Section 99-5-25, Mississippi Code of 1972, is 7 amended as follows:

99-5-25. (1) (a) If a defendant, prosecutor, or witness in 8 any criminal case, proceeding, or matter, fails to appear for any 9 proceeding as ordered by the court, then the court shall order the 10 bail forfeited and a bench warrant issued at the time of 11 nonappearance. The purpose of bail is to guarantee appearance and 12 13 bail shall not be forfeited for any other reason. Upon declaration of such forfeiture, the court shall issue a judgment 14 nisi. The clerk of the court shall notify the surety of the 15 forfeiture by writ of scire facias within five (5) working days of 16 the entry of such order of judgment nisi either by personal 17 service or by certified mail. Failure of the clerk to provide the 18 required notice within ten (10) working days shall constitute 19 20 prima facie evidence that the order should be set aside.

(b) The judgment nisi shall be returnable for ninety (90) days from the date of issuance. If during such period the defendant appears before the court, or is arrested and surrendered, then the judgement nisi shall be set aside. If the surety fails to produce the defendant and does not provide to the court reasonable mitigating circumstances upon such showing, then

Reasonable mitigating 28 circumstances shall be that the defendant is incarcerated in another jurisdiction, that the defendant is hospitalized under a 29 30 doctor's care, that the defendant is in a recognized drug rehabilitation program, that the defendant has been placed in a 31 32 witness protection program and it shall be the duty of any such agency placing such defendant into a witness protection program to 33 34 notify the court and the court to notify the surety, or any other 35 reason justifiable to the court.

If a final judgment is entered against a surety licensed 36 (2) 37 by the Department of Insurance and has not been set aside after ninety (90) days, or later if such time is extended by the court 38 issuing the judgment nisi, then the court shall order the 39 department to revoke the authority of such surety to write bail 40 41 bonds. The commissioner shall, upon notice of the court, notify said surety within five (5) working days of receipt of revocation. 42 43 If after ten (10) working days of such notification the 44 revocation order has not been set aside by the court, then the commissioner shall revoke the authority of the surety and all 45 46 agents of the surety and shall notify the sheriff of every county 47 of such revocation.

(3) If within twelve (12) months of the date of the final forfeiture the defendant appears for court, is arrested or surrendered to the court, or if the defendant is found to be incarcerated in another jurisdiction and a hold order placed on the defendant, then the amount of bail, less reasonable extradition cost, excluding attorney fees, shall be refunded by the court upon application by the surety.

55 SECTION 2. This act shall take effect and be in force from 56 and after July 1, 1999.
