Adopted AMENDMENT No. 1 PROPOSED TO

1 AMEND by adding the following sections after line 30 and 2 renumbering the succeeding section:

3 SECTION 2. Notwithstanding the provisions of any law to the contrary, for consideration of One Dollar (\$1.00), Northwest 4 5 Mississippi Community College District, by and through its board of trustees, may convey to the Benton County, Mississippi, School 6 7 District three and eighty-six one hundredths (3.86) acres of real property and the improvements thereon which are owned by the 8 Northwest Mississippi Community College District and which are 9 10 located in the Town of Ashland, Benton County, Mississippi, the property being more particularly described as follows: 11

12 3.86 acres of land, more or less, located in the 13 Southeast Quarter (SE 1/4) of Section 3, Township 3 14 South, Range 1 East, Benton County, Mississippi, and 15 more particularly described as follows:

COMMENCE at the Northwest Corner of the Southeast 16 17 Quarter (SE 1/4) of said Section 3, thence run South 990 feet to a point on the East boundary line of Mississippi 18 Highway No. 5; (said point is also the Southwest Corner 19 20 of a tract of land owned by L.L. Drennan); thence continue South 140 feet along the East boundary line of 21 said Mississippi Highway No. 5 to a stake at the point 22 of beginning; thence continue South along said East 23

24 boundary line of said Mississippi Highway No. 5 a distance of 704.7 feet to a point in the center of the 25 Fairgrounds Road; thence run East 362 feet along the 26 27 center of said Road to a point; thence run North a distance of 844.7 feet to a stake on a fence line; 28 thence run West 47 feet to a stake; thence run South 29 140 feet to a stake; thence run West 315 feet to the 30 point of beginning. 31

32 LESS AND EXCEPT:

2.15 acres, more or less, of land located in the
Southeast Quarter of Section 3, Township 3 South, Range
1 East, Benton County, Mississippi, and more
particularly described as follows:

Commence at the Northwest Corner of the Southeast 37 Quarter of said Section 3; thence run South 990 feet to 38 a point on the East boundary line of Highway Number 5, 39 40 (said point is the Southwest Corner of a tract of land 41 owned by L. L. Drennan); thence continue South 140 feet along the East boundary line of said Highway Number 5 to 42 43 a stake on the POINT OF BEGINNING; thence continue south along said East boundary line of Highway Number 5 a 44 distance of 240.66 feet; thence run East 362 feet to a 45 point; thence run North a distance of 380.66 feet to a 46 stake on a fence line; thence run West 47 feet to a 47 48 stake; thence run South 140 feet to a stake; thence run West 315 feet to the POINT OF BEGINNING. 49

50 SECTION 3. The Northwest Mississippi Community College 51 District shall retain all mineral rights to the property conveyed 52 pursuant to this act.

53 SECTION 4. This act shall be deemed to be full and complete 54 authority for the exercise of the powers herein granted.
