AMENDMENT No. 1 PROPOSED TO

House Bill NO. 1232

By Senator(s) Committee

**Amend by striking all after the enacting clause and inserting
in lieu thereof the following:**

10 SECTION 1. (1) The mileage of highway specifically
11 designated in subsection (2) of this section is in addition to the
12 total mileage limitation of eight thousand six hundred (8,600)
13 miles that is set out in Section 65-3-3.

14 (2) The following highway is designated as a state highway
15 and is placed under the jurisdiction of the Mississippi
16 Transportation Commission for construction and maintenance; and
17 such highway, together with the highways designated in Sections
18 65-3-3 and 65-3-5, and all other laws adding links to the
19 designated state highway system, are declared to be the state
20 highway system of Mississippi:

21 Southern District - Lawrence and Marion Counties:

22 An extension of Mississippi 44 beginning at its
23 intersection with Mississippi 27 in Lawrence County and
24 extending easterly across the Pearl River to Mississippi
25 13 in Marion County.

26 (3) The Mississippi Transportation Commission shall
27 maintain, construct, take over and assume jurisdiction of the
28 highway designated in subsection (1) of this section in the same
29 manner and upon the same terms and conditions as set out in
30 Sections 65-1-75, 65-3-3, 65-9-1 and 65-9-3.

31 SECTION 2. The following highway is deleted from the state
32 highway system, removed from the jurisdiction of the Mississippi
33 Transportation Commission and returned to the jurisdiction of the
34 Board of Supervisors of Wayne County:

35 Southern District - Wayne County:

36 Beginning on Mississippi 510 at the end of state
37 maintenance south of Mathersville, thence southeasterly
38 approximately 4.4 miles to Supervisors District 2 of
39 Wayne County.

40 SECTION 3. The following highway is deleted from the state
41 highway system, removed from the jurisdiction of the Mississippi
42 Transportation Commission and returned to the jurisdiction of the
43 Board of Supervisors of Humphreys County:

44 Central District - Humphreys County:

45 Mississippi 435 (Silent Shade Road) beginning at a point
46 on Mississippi 12 approximately 5 miles east of Belzoni,
47 thence northeasterly along the Yazoo River for 9 miles;
48 all in Humphreys County.

49 SECTION 4. This act shall take effect and be in force from
50 and after its passage.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**

1 AN ACT TO DESIGNATE A CERTAIN ADDITIONAL SECTION OF HIGHWAY
2 IN LAWRENCE AND MARION COUNTIES AS A PART OF THE STATE HIGHWAY
3 SYSTEM AND TO PLACE IT UNDER THE JURISDICTION OF THE MISSISSIPPI
4 TRANSPORTATION COMMISSION; TO DELETE A CERTAIN SECTION OF HIGHWAY
5 IN WAYNE COUNTY AND A CERTAIN SECTION OF HIGHWAY IN HUMPHREYS
6 COUNTY FROM THE STATE HIGHWAY SYSTEM; TO REMOVE THEM FROM THE
7 JURISDICTION OF THE MISSISSIPPI TRANSPORTATION COMMISSION; AND FOR
8 RELATED PURPOSES.
