## Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 10 SECTION 1. (1) The mileage of highway specifically designated in subsection (2) of this section is in addition to the 11 total mileage limitation of eight thousand six hundred (8,600) 12 miles that is set out in Section 65-3-3. 13 (2) The following highway is designated as a state highway 14 and is placed under the jurisdiction of the Mississippi 15 Transportation Commission for construction and maintenance; and 16 such highway, together with the highways designated in Sections 17 65-3-3 and 65-3-5, and all other laws adding links to the 18 19 designated state highway system, are declared to be the state highway system of Mississippi: 20 21 Southern District - Lawrence and Marion Counties: An extension of Mississippi 44 beginning at its 22 intersection with Mississippi 27 in Lawrence County and 23 24 extending easterly across the Pearl River to Mississippi
- extending easterly across the Pearl River to Mississippi

  13 in Marion County.

  (3) The Mississippi Transportation Commission shall

  maintain, construct, take over and assume jurisdiction of the

  highway designated in subsection (1) of this section in the same

  manner and upon the same terms and conditions as set out in

  Sections 65-1-75, 65-3-3, 65-9-1 and 65-9-3.

- 36 Beginning on Mississippi 510 at the end of state

- 40 SECTION 3. The following highway is deleted from the state
- 41 highway system, removed from the jurisdiction of the Mississippi

- 45 Mississippi 435 (Silent Shade Road) beginning at a point
