1 2 3	AN ACT TO AMEND SECTION 63-1-33, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT AN APPLICANT FOR A MISSISSIPPI DRIVER'S LICENSE WHO, AT THE TIME OF APPLICATION, HOLDS A VALID MOTOR VEHICLE DRIVER'S
4	LICENSE ISSUED BY ANOTHER STATE SHALL NOT BE REQUIRED TO TAKE A
5	WRITTEN TEST; AND FOR RELATED PURPOSES.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
7	SECTION 1. Section 63-1-33, Mississippi Code of 1972, is
8	amended as follows:
9	63-1-33. It shall be the duty of the license examiner, when
10	application is made for an operator's license or temporary driving
11	permit, to test the applicant's ability to read and understand
12	road signs and to give the required signals as adopted by the
13	National Advisory Committee on Uniform Traffic Control Devices and
14	the American Association of Motor Vehicle Administrators.
15	The commissioner shall have prepared and administer a test
16	composed of at least ten (10) questions relating to the safe
17	operation of a motor vehicle and testing the applicant's knowledge
18	of the proper operation of a motor vehicle.
19	Prior to the administration of the test the license examiner
20	shall inspect the horn, lights, brakes, inspection certificate and
21	vehicle registration of the motor vehicle which the applicant
22	expects to operate while being tested, and if he finds that any of
23	the aforementioned items are deficient, no license or endorsement
24	shall be issued to the applicant until same have been repaired.
25	An applicant for a Mississippi driver's license who, at the
26	time of application, holds a valid motor vehicle driver's license
27	issued by another state shall not be required to take a written

- 28 <u>test.</u>
- 29 Except as otherwise provided by Section 63-1-6, when
- 30 application is made for an original motorcycle endorsement or a
- 31 restricted motorcycle operator's license, the applicant shall be
- 32 required to pass a written test which consists of questions
- 33 relating to the safe operation of a motorcycle and a skill test
- 34 similar to the "Motorcycle Operator Skill Test," which is endorsed
- 35 by the American Association of Motor Vehicle Administrators. The
- 36 commissioner may exempt any applicant from the skill test if the
- 37 applicant presents a certificate showing successful completion of
- 38 a course approved by the commissioner, which includes a similar
- 39 examination of skills needed in the safe operation of a
- 40 motorcycle.
- 41 SECTION 2. This act shall take effect and be in force from
- 42 and after July 1, 2000.
