HOUSE BILL NO. 311

AN ACT TO PROVIDE THAT NO PERSON SHALL PERFORM BODY PIERCING UPON ANY PERSON FOR COMPENSATION WITHOUT FIRST REGISTERING WITH 2 THE STATE DEPARTMENT OF HEALTH; TO DEFINE "BODY PIERCING"; TO 3 4 PROVIDE FOR AN ANNUAL REGISTRATION FEE; TO PROVIDE THAT THE STATE BOARD OF HEALTH SHALL PROMULGATE RULES AND REGULATIONS REGARDING 5 THE SANITATION OF BODY PIERCING FACILITIES, STERILIZATION OF BODY 6 PIERCING APPARATUS AND PROCEDURES TO PREVENT THE TRANSMISSION OF 7 8 DISEASE DURING BODY PIERCING PROCEDURES; TO AUTHORIZE THE DEPARTMENT TO VISIT ANY BODY PIERCING FACILITY DURING BUSINESS 9 HOURS TO ENSURE COMPLIANCE AND TO REQUIRE THE DEPARTMENT TO 10 INSPECT EACH SUCH FACILITY AT LEAST ONCE A YEAR; TO AUTHORIZE THE 11 DEPARTMENT TO SUSPEND OR REVOKE THE REGISTRATION OF ANY PERSON 12 VIOLATING THE RULES OR REGULATIONS OF THE BOARD; TO PROHIBIT BODY 13 PIERCING UPON ANY PERSON UNDER 18 YEARS OF AGE; TO PROVIDE FOR A 14 15 CRIMINAL PENALTY FOR VIOLATIONS; TO AUTHORIZE THE DEPARTMENT TO BRING AN INJUNCTIVE ACTION TO PROHIBIT PERSONS FROM VIOLATING THIS 17 ACT; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 18 SECTION 1. (1) For the purposes of this section, the term 19 "body piercing" means the creation of an opening in any part of 20 the human body, other than the outer perimeter or lobe of the ear, 21 for the purpose of inserting jewelry or other decorative object, 22 or for some other nonmedical purpose. 23 24 (2) No person shall perform body piercing upon any person for compensation within the State of Mississippi without first 25 registering with the State Department of Health. The facility or 26

premises in which body piercing is to be performed shall be

specified in the registration, and the registered person shall be

- 29 authorized to perform body piercing only in the specified facility
- 30 or premises. Registrations shall be valid for one (1) year, and
- 31 each person registered under this section shall pay an annual
- 32 registration fee to the department in an amount set by the
- department, but not to exceed One Hundred Fifty Dollars (\$150.00),
- 34 which fee shall be uniform for all registered persons.
- 35 (3) The State Board of Health shall promulgate rules and
- 36 regulations relating to:
- 37 (a) Health, cleanliness and general sanitation of the
- 38 facilities or premises in which body piercing is performed or to
- 39 be performed;
- 40 (b) Sterilization of body piercing apparatus and safe
- 41 disposal of body piercing apparatus;
- 42 (c) Procedures to prevent the transmission of disease
- 43 or infection during or relating to body piercing procedures,
- 44 specifically including, but not limited to, transmission of
- 45 Hepatitis B and the human immunodeficiency virus (HIV); and
- 46 (d) Such other administrative provisions as may be
- 47 necessary to protect public health or properly administer the
- 48 requirements of this section.
- 49 (4) Representatives of the department may visit any facility
- or premises in which body piercing is performed at any time during
- 51 business hours to ensure compliance with the requirements of this
- 52 section and the rules and regulations promulgated under this
- 53 section. Representatives of the department shall visit each
- 54 facility or premises in which body piercing is performed not less
- 55 than once each year to inspect for such compliance. The
- 56 department may suspend or revoke the registration of any person
- 57 found to be violating any of the rules or regulations promulgated
- 58 under this section.
- 59 (5) It shall be unlawful for any person to perform body

- 60 piercing upon any person under the age of eighteen (18) years.
- 61 (6) Any person who performs body piercing for compensation
- 62 without first registering with the department or after his
- 63 registration has been suspended or revoked by the department, or
- 64 any person who performs body piercing upon any person in violation
- of subsection (5) of this section, is guilty of a misdemeanor and,
- 66 upon conviction, shall be punished by a fine of not less than One
- 67 Hundred Dollars (\$100.00) nor more than Five Hundred Dollars
- 68 (\$500.00).
- 69 (7) The department is authorized to bring an action for an
- 70 injunction under the provisions of Sections 73-51-1 through
- 71 73-51-5 to prohibit any person who is required to be registered
- 72 under this section from performing body piercing without first
- 73 registering with the department or after his registration has been
- 74 suspended or revoked by the department.
- 75 (8) This section shall not apply to physicians licensed to
- 76 practice medicine in Mississippi in the performance of their
- 77 professional duties.
- 78 SECTION 2. This act shall take effect and be in force from
- 79 and after July 1, 2000.
