- 2 REVISE THE DATE FOR PUBLICATION OF THE COUNTY BUDGET; AND FOR
- 3 RELATED PURPOSES.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 SECTION 1. Section 19-11-7, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 [With regard to any county which is exempt from the
- 8 provisions of Section 19-2-3, this section shall read as follows:]
- 9 19-11-7. The board of supervisors of each county of the
- 10 State of Mississippi shall, at its August meeting of each year,
- 11 prepare a complete budget of revenues, expenses and a working cash
- 12 balance estimated for the next fiscal year, which shall be based
- on the aggregate funds estimated to be available for the ensuing
- 14 fiscal year for each fund, from which such estimated expenses will
- 15 be paid, exclusive of school maintenance funds, which shall be
- 16 shown separately. Such statement of revenues shall show every
- 17 source of revenue along with the amount derived from each source.
- 18 The budget containing such statement of revenues and expenses
- 19 shall be published at least one (1) time during August or
- 20 September but not later than September 30 of the year in a
- 21 newspaper published in the county, or if no newspaper is published

- 22 therein, then in a newspaper having a general circulation therein.
- 23 [With regard to any county which is required to operate on a
- 24 countywide system of road administration as described in Section
- 25 19-2-3, this section shall read as follows:]
- 26 19-11-7. The county administrator of each county of the
- 27 State of Mississippi shall prepare and submit to the board of
- 28 supervisors at its August meeting of each year a complete budget
- 29 of revenues, expenses and a working cash balance estimated for the
- 30 next fiscal year, which shall be based on the aggregate funds
- 31 estimated to be available for the ensuing fiscal year for each
- 32 fund, from which such estimated expenses will be paid, exclusive
- 33 of school maintenance funds, which shall be shown separately and
- 34 exclusive of the budget of the sheriff's department which shall be
- 35 prepared by the sheriff. Such statement of revenues shall show
- 36 every source of revenue along with the amount derived from each
- 37 source. The budget, including the sheriff's budget, containing
- 38 such statement of revenues and expenses shall be published at
- 39 least one (1) time during August or September but not later than
- 40 September 30 of the year in a newspaper published in the county,
- 41 or if no newspaper is published therein, then in a newspaper
- 42 having a general circulation therein.
- 43 SECTION 2. This act shall take effect and be in force from
- 44 and after July 1, 2000.
