HOUSE BILL NO. 672

1 AN ACT RELATING TO THE REGULATION OF CERTAIN FOOD LAWS BY THE  
2 STATE BOARD OF HEALTH; TO REPEAL SECTIONS 75-29-301 THROUGH  
3 75-29-315, MISSISSIPPI CODE OF 1972, WHICH CONSTITUTE THE  
4 "DEGERMINATED CORN MEAL AND GRITS LAW"; TO REPEAL SECTIONS  
5 75-29-401 THROUGH 75-29-415, MISSISSIPPI CODE OF 1972, WHICH  
6 CONSTITUTE THE "FLOUR AND BREAD ENRICHMENT LAW"; TO REPEAL  
7 SECTIONS 75-29-501 THROUGH 75-29-511, MISSISSIPPI CODE OF 1972,  
8 WHICH CONSTITUTE THE "OLEOMARGARINE ENRICHMENT LAW"; TO REPEAL  
9 SECTIONS 75-37-1 THROUGH 75-37-35, MISSISSIPPI CODE OF 1972, WHICH  
10 IS THE "FROZEN FOOD LOCKER PLANT LAW"; AND FOR RELATED PURPOSES.

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

12 SECTION 1. Sections 75-29-301, 75-29-303, 75-29-305,  
13 75-29-307, 75-29-309, 75-29-311, 75-29-313 and 75-29-315,  
14 Mississippi Code of 1972, which constitute the "Degerminated Corn  
15 Meal and Grits Law," are hereby repealed.

16 SECTION 2. Sections 75-29-401, 75-29-403, 75-29-405,  
17 75-29-407, 75-29-409, 75-29-411, 75-29-413 and 75-29-415,  
18 Mississippi Code of 1972, which constitute the "Flour and Bread  
19 Enrichment Law," are hereby repealed.

20 SECTION 3. Sections 75-29-501, 75-29-503, 75-29-505,  
21 75-29-507, 75-29-509 and 75-29-511, Mississippi Code of 1972,  
22 which constitute the "Oleomargarine Enrichment Law," are hereby  
23 repealed.

24 SECTION 4. Sections 75-37-1, 75-37-3, 75-37-5, 75-37-7,  
25 75-37-9, 75-37-11, 75-37-13, 75-37-15, 75-37-17, 75-37-19,

26 75-37-21, 75-37-23, 75-37-25, 75-37-27, 75-37-29, 75-37-31,  
27 75-37-33 and 75-37-35, Mississippi Code of 1972, which constitute  
28 the "Frozen Food Locker Plant Law," are hereby repealed.

29 SECTION 5. This act shall take effect and be in force from  
30 and after July 1, 2000.
