1 AN ACT TO AMEND SECTION 23-15-573, MISSISSIPPI CODE OF 1972,  
2 TO PROVIDE FOR THE CREATION OF A UNIFORM AFFIDAVIT BALLOT; AND FOR  
3 RELATED PURPOSES.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 SECTION 1. Section 23-15-573, Mississippi Code of 1972, is  
6 amended as follows:

7 23-15-573. Any person whose name does not appear upon the  
8 pollbooks shall be permitted to vote in an election; but if any  
9 person offering to vote in any election whose name does not appear  
10 upon the pollbook shall make affidavit before one (1) of the  
11 managers of election in writing that he is entitled to vote, or  
12 that he has been illegally denied registration, his vote may be  
13 prepared by him and handed to the proper election officer who  
14 shall enclose the same in an envelope with the written affidavit  
15 of the voter, \* \* \* seal the envelope and mark plainly upon it the  
16 name of the person offering to vote. The affidavit must include  
17 the complete name, all required addresses and telephone numbers,  
18 and the signature of the affiant, and must include the signature  
19 of one (1) of the election managers. A separate register shall be  
20 maintained for affidavit ballots, and the affiant shall sign the  
21 register upon completing an affidavit under this section. In  
22 canvassing the returns of the election, the executive committee in  
23 primary elections, or the election commissioners, in a general  
24 election, \* \* \* shall examine the records and allow the ballot to  
25 be counted, or not counted, as it appears to be legal.

26 The uniform affidavit ballot shall be in substantially the

73 SECTION 2. If the enactment of any state or federal law  
74 shall require any modification to the form or language of the  
75 affidavit prescribed in this section, then the Secretary of State  
76 shall be authorized to promulgate an amended form of the affidavit  
77 to comply with the requirements of any such state or federal law,  
78 which shall be required to be used in all elections throughout  
79 this state.

80 SECTION 3. The Attorney General of the State of Mississippi  
81 shall submit this act, immediately upon approval by the Governor,  
82 or upon approval by the Legislature subsequent to a veto, to the  
83 Attorney General of the United States or to the United States  
84 District Court for the District of Columbia in accordance with the  
85 provisions of the Voting Rights Act of 1965, as amended and  
86 extended.

87 SECTION 4. This act shall take effect and be in force from  
88 and after the date it is effectuated under Section 5 of the Voting  
89 Rights Act of 1965, as amended and extended.
