- 2 PROVIDE THAT PRIMITIVE WEAPON HUNTERS AND BOWHUNTERS SHALL BE
- 3 ALLOWED TO HUNT STATEWIDE AFTER THE END OF THE LAST SEASON FOR
- 4 HUNTING DEER WITH GUNS AND WITH DOGS; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 SECTION 1. Section 49-7-31, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 49-7-31. (1) The open season for game birds and game
- 9 animals shall be as follows:
- 10 (a) On bobwhite quail: The season shall open on
- 11 Thanksgiving day and run through the first Saturday in March next
- 12 following.
- 13 (b) On pheasant: There shall be no open season on
- 14 pheasant.
- 15 (c) On wild turkey: The commission shall fix the
- 16 spring season between the Saturday nearest March 20 and May 1 in
- 17 designated areas. In addition, the commission may fix special
- 18 fall either-sex seasons.
- 19 (d) On squirrel:
- 20 (i) Zone 1: For areas north of Highway 82 plus
- 21 those portions of Sunflower County and Washington County south of
- 22 Highway 82 the season shall open on the Saturday nearest October 1

- 23 and run through February 28.
- 24 (ii) Zone 2: For areas between Highway 82 and
- 25 Highway 84, plus such portions of the state south of Highway 84
- 26 and west of Interstate 55, the season shall open on the Saturday
- 27 nearest October 15 and run through February 28.
- 28 (iii) Zone 3: For areas south of Highway 84 and
- 29 east of Interstate 55 the season shall open on the last Saturday
- 30 in October and run through February 28.
- 31 (e) On deer:
- 32 (i) With bow and arrow: October 1 through the
- 33 Friday prior to Thanksgiving.
- 34 (ii) With guns and with dogs: From the Saturday
- 35 prior to Thanksgiving through December 1.
- 36 (iii) With primitive weapons and without dogs:
- 37 December 2 through December 15.
- 38 (iv) With guns and without dogs: December 16
- 39 through December 23. However, the commission shall allow hunting
- 40 statewide \* \* \* with any legal weapon, including bow and arrow and
- 41 <u>primitive weapons</u>, without dogs after the end of the last season
- 42 for hunting deer with guns and with dogs, but the season with
- 43 legal designated weapons and without dogs shall not extend beyond
- 44 January 31.
- 45 (v) With guns and with dogs: December 24 through
- 46 a date fixed by the commission that will provide a total of
- 47 thirty-nine (39) days of hunting deer with guns and with dogs when
- 48 added to the number of days provided for hunting deer with guns
- 49 and with dogs in paragraph (e)(ii).
- 50 (vi) When hunting deer during any gun season on
- 51 deer, a hunter must wear in full view five hundred (500) square
- 52 inches of solid unbroken fluorescent orange.
- 53 (vii) In order to set and regulate the deer

- 54 seasons, the commission may:
- A. Set and regulate the deer seasons on
- 56 wildlife management areas which it administers;
- B. Allow the harvesting of antlerless deer in
- 58 the districts or zones upon the recommendation of the executive
- 59 director based upon good and substantial quantitative data and
- 60 research evaluations that demonstrate that the harvesting is
- 61 necessary to properly manage the herd. The commission, only upon
- 62 the recommendation of the executive director, may allow the
- 63 harvesting of antlerless deer during the deer season with guns and
- 64 with dogs by a majority vote of the commission. Nothing in this
- 65 section prohibits the harvesting of either sex deer by landowners
- or leaseholders on private lands under a deer management program
- 67 prescribed or approved by the executive director.
- 68 C. Provide a special permit for the
- 69 harvesting of deer when they are depredating and destroying crops.
- 70 The department shall supervise the harvesting and provide for the
- 71 salvaging of the meat of the animals. The commission may
- 72 authorize the department to assist any farmer in this state, who
- 73 sustains crop damage by wildlife, in eradication of the problem
- 74 wildlife.
- 75 (viii) The commission shall establish a special
- 76 hunting season for youth under the age of sixteen (16) and for
- 77 handicapped persons in the Natchez State Park. The commission
- 78 shall also establish a primitive weapon season in the Natchez
- 79 State Park. The selection of participants in the primitive weapon
- 80 season shall be by public drawing from all qualified applications.
- 81 The commission shall set the number of permits to be issued and

- 82 the length of the special seasons. The commission may also
- 83 establish a special hunting season for youth and handicapped
- 84 persons or a primitive weapon season as provided in this
- 85 subparagraph in any other state park under the jurisdiction of the
- 86 department but shall only do so upon the recommendation of the
- 87 staff of the department as approved by the commission. The
- 88 commission shall select participants and set the number of permits
- 89 to be issued and the length of the special seasons in the manner
- 90 provided in this subparagraph.
- 91 (ix) The commission may establish and regulate
- 92 special youth hunts for all nonmigratory game birds and animals
- 93 outside of the open season on wildlife management areas and on
- 94 private lands.
- 95 (f) On fur-bearing animals: The commission may fix the
- 96 open season on fur-bearing animals between November 1 and March 1
- 97 next following and fix the open season for hunting opossums,
- 98 raccoons and bobcats with dogs and guns by licensed hunters from
- 99 October 1 to February 28 next following; but raccoons and bobcats
- 100 may be run, hunted, chased or pursued throughout the year with
- 101 dogs by licensed hunters. The commission may establish an
- 102 additional open season on raccoon from July 1 through October 1,
- 103 and the bag limit on raccoon during the additional open season
- 104 shall be one (1) per party, per night.
- 105 (g) On rabbits: The season shall open on the Saturday
- 106 nearest October 15 and run through February 28 next following, and
- 107 when rabbits are depredating or destroying crops, the owner of the
- 108 crops or his tenants may shoot the rabbits with guns.
- 109 (h) On predatory animals: The hunting of predatory

- 110 animals shall be restricted to the open seasons for hunting any
- 111 game animal or game bird, using only the firearms, ammunition,
- 112 primitive weapons or archery equipment legal for use during that
- 113 open season. Landowners, agricultural leaseholders or their
- 114 designated agents may take predatory animals year-round on lands
- 115 owned or leased by them. The taking of any animal or animals
- 116 other than beavers or coyote by the use of a trap or traps is
- 117 unlawful except during the time the season is open for the taking
- 118 of fur-bearing animals. Fox and coyote may be run, chased or
- 119 pursued with dogs except as provided in Section 49-7-32 year-round
- 120 by licensed hunters.
- 121 (i) On migratory birds: The open season for migratory
- 122 birds shall be the season prescribed by the Federal Migratory Bird
- 123 Treaty regulations.
- 124 (j) On nongame gross fish: The season for taking
- 125 nongame gross fish by hand or with grappling tongs shall be from
- 126 May 1 to July 15.
- 127 (k) It is unlawful to trap fox after the closed season
- 128 for trapping of other fur-bearing animals, except on property
- 129 owned or leased by the person trapping.
- 130 (2) It is the intent of the Legislature that the open season
- 131 for game birds and game animals shall be stabilized unless some
- 132 unforeseen calamity affecting the resource necessitates earlier
- 133 change.
- 134 SECTION 2. This act shall take effect and be in force from
- 135 and after July 1, 2000.
