HOUSE BILL NO. 1082 (As Passed the House)

1 AN ACT TO AMEND SECTION 49-15-313, MISSISSIPPI CODE OF 1972, 2 TO REQUIRE A SEPARATE LICENSE FEE FOR CERTAIN NONRESIDENT CHARTER 3 BOATS; AND FOR RELATED PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
SECTION 1. Section 49-15-313, Mississippi Code of 1972, is
amended as follows:[LTR1]

7 49-15-313. (1) Any resident between the ages of sixteen 8 (16) and sixty-five (65) years, as defined in Section 49-7-3, 9 fishing in the marine waters of the state, shall obtain a saltwater sports fishing license for a fee of Four Dollars 10 (\$4.00). This license shall be valid in any waters south of 11 12 Interstate 10. Any resident citizen who is blind, paraplegic or a 13 multiple amputee, or who has been adjudged by the Veterans Administration as having a total service-connected disability, or 14 has been adjudged totally disabled by the Social Security 15 Administration shall not be required to purchase or have in his 16 possession a saltwater sports fishing license while engaged in 17 such activities. Any resident exempt under this section shall 18 have on his person while fishing proof of residency and age or 19 20 disability.

(2) The commission shall prescribe the forms, types and fees for nonresident saltwater sports fishing licenses except that the fee for a nonresident saltwater sports fishing license shall not be less than Twenty Dollars (\$20.00). The commission shall require a nonresident to purchase a nonresident freshwater fishing license and a nonresident saltwater sports fishing license if the

H. B. No. 1082 00\HR03\R1549CS PAGE 1 27 nonresident's state requires both licenses for a nonresident to 28 fish in its marine waters.

(3) All <u>resident</u> vessels engaged in charter boat fishing, 29 30 party boat fishing, head boat and guide boat fishing shall be 31 issued a separate annual license by the commission at a fee of Two Hundred Dollars (\$200.00). All nonresident vessels engaged in 32 charter boat fishing, party boat fishing, headboat and guide boat 33 fishing shall be issued a separate annual license by the 34 commission at a fee of Eight Hundred Dollars (\$800.00). If the 35 applicant's domicile state charges a greater fee than the 36 nonresident fee of Eight Hundred Dollars (\$800.00) for residents 37 of Mississippi, then the applicant must pay the same fee that the 38 applicant's domicile state charges a resident of Mississippi. 39 Crew members and customers of the licensed vessels shall not be 40 required to purchase an individual resident or nonresident 41 42 saltwater fishing license while sponsored by the licensed vessels. An operator of a licensed vessel shall be required to report the 43 44 number of customers to the department as required by the commission and the information shall be kept confidential and 45 46 shall not be released, except to other fisheries management agencies or as statistical data. All nonresident vessels engaged 47 48 in saltwater sport fishing tournaments, not to exceed an aggregate of twenty (20) days per calendar year, shall not be required to 49 purchase an annual license as provided under this subsection. 50

51 (4) The saltwater sports fishing license is required for <u>all</u>
52 <u>recreational methods of finfish harvest</u>.

53 (5) Any resident who purchases a lifetime sportsman's 54 license, in accordance with Section 49-7-153, shall be entitled to 55 fish in the marine salt waters of the state and shall be exempt 56 from the purchase of a sport saltwater fishing license.

57 (6) Any person authorized to issue a license may collect and 58 retain, for each saltwater fishing license issued, the additional 59 fee authorized under Section 49-7-17.

(7) The fees collected from the sale of resident and
nonresident saltwater sports fishing licenses shall be deposited
into the Seafood Fund and shall be used solely for the management
of marine resources.

66 (9) July 4 of each year is designated as "Free Saltwater
67 Sports Fishing Day." Any person may saltwater sport fish without
68 a license on the "Free Saltwater Sports Fishing Day."

69 SECTION 2. This act shall take effect and be in force from70 and after July 1, 2000.
