| 11 | SECTION 1. Section 41-4-21, Mississippi Code of 1972, is |

| 13 | 41-4-21. (1) For the operations of all facilities placed |
| 14 | under the control of the department and for all of its operations, |
| 15 | the board shall adopt a uniform system of reporting and accounting |
| 16 | approved by the State Department of Audit, and shall prepare an |
| 17 | annual report to the Legislature setting forth the disbursements |
| 18 | of all moneys appropriated and specifying the facilities and |
