4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. The following sum, or so much thereof as may be 6 necessary, is hereby appropriated out of any money in the State 7 General Fund not otherwise appropriated, for the purpose of defraying the expenses of the Mississippi Arts Commission for the 8 fiscal year beginning July 1, 2000, and ending June 30, 2001..... 9 10\$ 1,727,824.00. SECTION 2. The following sum, or so much thereof as may be 11 12 necessary, is hereby appropriated out of any money in the special 13 fund in the State Treasury to the credit of the Mississippi Arts Commission which is comprised of special source funds and 14 donations collected by or otherwise available to the commission, 15 for the purpose of defraying the expenses of the commission for 16 the fiscal year beginning July 1, 2000, and ending June 30, 2001.. 17\$ 919,157.00. 18 SECTION 3. 64 Any transfers or escalations shall be made in accordance with 65 the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

SECTION 4. Of the funds appropriated under the provisions of Section 2, funds in the amount of Four Hundred Fifty Thousand Dollars (\$450,000.00) shall be derived from the Education Enhancement Fund pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of 1972, for the following:

76 of arts programs in public schools . . . \$100,000.00 77 Miscellaneous grants and programs \$350,000.00 78 SECTION 5. It is the intention of the Legislature that the Arts Commission shall have the authority to transfer dollars 79 appropriated in the major object of expenditure "Subsidies, Loans 80 and Grants," designated for the "Challenge Program," specific 81 82 amounts to a special fund in the State Treasury called the Arts 83 Commission Challenge Initiative Fund. The unexpended amounts remaining in the fund at the end of a fiscal year shall not lapse 84 85 into the State General Fund and may be expended by the commission 86 in subsequent fiscal years upon appropriation of the Legislature. Any interest earned on the fund shall be deposited to the credit 87 of the fund and may be disbursed by the commission upon 88 appropriations of the Legislature. It is the intention of the 89 90 Legislature that the commission may award grants to arts organizations from monies in the fund and the grantees will be 91 required to provide matching funds for the grants in an amount of 92

94 SECTION 6. It is the intention of the Legislature that the 95 Mississippi Arts Commission shall have the authority to escalate 96 its budget and expend funds from any source available not to 97 exceed Two Hundred Thousand Dollars (\$200,000.00), that may become 98 available to the Commission in accordance with the rules and 99 regulations of the Department of Finance and Administration in a 100 manner consistent with the escalation of federal funds.

SECTION 7. The money herein appropriated shall be paid by 101 102 the State Treasurer out of any money in the State Treasury to the 103 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 104 105 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 106 SECTION 8. This act shall take effect and be in force from 107 108 and after July 1, 2000.
