1 2 3	AN ACT MAKING AN APPROPRIATION FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE MISSISSIPPI AUTHORITY FOR EDUCATIONAL TELEVISION FOR THE FISCAL YEAR 2001.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the purpose of
8	defraying the expenses of the Mississippi Authority for
9	Educational Television for the fiscal year beginning July 1, 2000,
10	and ending June 30, 2001\$ 7,011,039.00.
11	SECTION 2. The following sum, or so much thereof as may be
12	necessary, is hereby appropriated out of any money in the special
13	fund in the State Treasury to the credit of the Mississippi
14	Authority for Educational Television which is comprised of special
15	source funds collected by or otherwise available to the Authority,
16	for the purpose of defraying the expenses of the Authority for the
17	fiscal year beginning July 1, 2000, and ending June 30, 2001
18	\$ 5,857,774.00.
19	SECTION 3. Of the funds appropriated under the provisions of
20	Section 1 and Section 2, not more than the amounts set forth below
21	shall be expended for the respective major objects or purposes of

44	the Legislature that it shall be the agency's responsibility to
45	make certain that funds required to be appropriated for "Personal
46	Services" for Fiscal Year 2002 do not exceed Fiscal Year 2001
47	funds appropriated for that purpose, unless programs or positions
48	are added to the agency's Fiscal Year 2002 budget by the
49	Mississippi Legislature. Based on data provided by the
50	Legislative Budget Office, the State Personnel Board shall

- 90 authority to expend funds in the Capital Equipment Replacement
- 91 Revolving Fund, in accordance with Section 37-63-17, Mississippi
- 92 Code of 1972, Annotated, for the purpose of purchasing technical
