4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	Treasury to the credit of the Mississippi Athletic Commission
8	Fund, for the purpose of defraying the expenses of the Mississippi
9	Athletic Commission for the fiscal year beginning July 1, 2000,
10	and ending June 30, 2001\$ 110,096.00.
11	SECTION 2. With the funds approved for expenditure under
12	Section 1, the following positions are authorized:
13	AUTHORIZED POSITIONS:
14	Permanent: Full Time 0
15	Part Time 0
16	Time-Limited: Full Time 0
17	Part Time 0
18	With the funds herein appropriated, it is the intention of
19	the Legislature that it shall be the agency's responsibility to
20	make certain that funds required to be appropriated for "Personal
21	Services" for Fiscal Year 2002 do not exceed Fiscal Year 2001
22	funds appropriated for that purpose, unless programs or positions
23	are added to the agency's Fiscal Year 2002 budget by the
24	Mississippi Legislature. Based on data provided by the
25	Legislative Budget Office, the State Personnel Board shall
26	determine and publish the projected annual cost to fully fund all

- 27 appropriated positions in compliance with the provisions of this
- 28 act. It shall be the responsibility of the agency head to insure
- 29 that no single personnel action increases this projected annual
- 30 cost and/or the Fiscal Year 2001 appropriation for "Personal
- 31 Services" when annualized. If, at the end of any calendar month,
- 32 the State Personnel Board determines that the agency has taken
- 33 action(s) which would cause the agency to exceed this projected
- 34 annual cost or the Fiscal Year 2001 "Personal Services"
- 35 appropriated level, when annualized, then only those actions which
- 36 reduce the projected annual cost and/or the appropriation
- 37 requirement will be processed by the State Personnel Board until
- 38 such time as the requirements of this provision are met.
- 39 Any transfers or escalations shall be made in accordance with
- 40 the terms, conditions and procedures established by law.
- No general funds authorized to be expended herein shall be
- 42 used to replace federal funds and/or other special funds which are
