If, at the end of any calendar month, 32 the State Personnel Board determines that the agency has taken action(s) which would cause the agency to exceed this projected 33 annual cost or the Fiscal Year 2001 "Personal Services" 34 appropriated level, when annualized, then only those actions which 35 reduce the projected annual cost and/or the appropriation 36 37 requirement will be processed by the State Personnel Board until such time as the requirements of this provision are met. 38

Any transfers or escalations shall be made in accordance withthe terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

SECTION 3. The money herein appropriated shall be paid by 45 46 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 47 warrants issued by the State Fiscal Officer; and the State Fiscal 48 Officer shall issue his warrants upon requisitions signed by the 49 proper person, officer or officers in the manner provided by law. 50 51 SECTION 4. This act shall take effect and be in force from and after July 1, 2000. 52
