61 Any transfers or escalations shall be made in accordance with 62 the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

67 SECTION 3. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 68 69 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 70 71 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 72 73 SECTION 4. This act shall take effect and be in force from and after July 1, 2000. 74
