110 \*Appropriation, revenue, and local and private bills, and 111 bills to restore suffrage are excluded from these deadlines. For purposes of the deadlines herein set forth, the term "revenue 112 113 bills" shall include only those bills whose primary purpose is to 114 increase or decrease taxes or to authorize the issuance of bonds or the borrowing of money. Bills which are primarily for 115 116 regulatory purposes which have revenue provisions included shall not be considered as revenue bills for deadline purposes. 117 deletion from a bill of the features which made it a revenue bill 118 119 shall render the bill a general bill for deadline purposes. 120 \*\*Conference reports on all bills must be filed with the 121 Secretary/Clerk no later than the time of adjournment on the day prior to being called up and considered. Appropriation bills 122 123 which actually appropriate money and are recommitted for further 124 conference are excluded from the requirement that the subsequent conference report be filed and lay on table one (1) day before 125 126 being considered; however, original action must be taken on all 127 appropriation conference reports by 2:00 p.m. on the 84th/119th day and subsequent reports must be filed no later than 6:00 p.m. 128 129 \*\*\*Requests for general bills and constitutional amendments 130 to be drafted must be made no later than 8:00 p.m. on the 131 10th/45th day \* \* \*. The Rules Committee of the House or Senate, 132 as the case may be, may authorize any member of its respective 133 house to make requests, for one or more general bills or 134 constitutional amendments to be drafted, after the expiration of 135 the deadline for making such drafting requests but before the 136 deadline for introduction of bills and constitutional amendments, 137 upon a determination by the Rules Committee that such drafting

- 138 requests are in response to conditions of an emergency nature
- 139 arising subsequent to the deadline for making requests for general
- 140 bills and constitutional amendments to be drafted.
- +Committee reports and conference reports that are subject to
- 142 being filed on these deadlines must be filed with the
- 143 Secretary/Clerk no later than 8:00 p.m.
- 144 Whenever the word "day" appears in this rule, it shall mean
- 145 calendar day.
- 146 The above schedule shall not be deviated from except by the
- 147 passage of a concurrent resolution adopted by a vote of two-thirds
- (2/3) of the membership of the House and Senate present and
- 149 voting."
