- MISSISSIPPI CODE OF 1972, TO CHANGE REFERENCES IN THE PROFESSIONAL
- 3 ART THERAPISTS REGULATORY LAW FROM "CERTIFICATE" TO "LICENSE"; TO
- 4 BRING FORWARD SECTION 73-65-17, MISSISSIPPI CODE OF 1972; TO
- 5 REPEAL SECTION 73-65-19, MISSISSIPPI CODE OF 1972, WHICH
- 6 AUTOMATICALLY REPEALS THE PROFESSIONAL ART THERAPISTS
- 7 CERTIFICATION LAW; AND FOR RELATED PURPOSES.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 SECTION 1. Section 73-65-1, Mississippi Code of 1972, is
- 10 amended as follows:[JU1]
- 11 73-65-1. As used in this chapter, unless the context
- 12 otherwise requires:
- 13 (a) "Board" means the State Board of Health;
- 14 (b) "<u>Licensed</u> professional art therapist" means a
- 15 person who has completed a master's or doctoral degree program in
- 16 art therapy, or an equivalent course of study, from an accredited
- 17 educational institution and who is <u>licensed</u> by the <u>State Board of</u>
- 18 <u>Health</u>, or who received registration from the American Art Therapy
- 19 Association (ATR) before 1980;
- 20 (c) "<u>License</u> holder" means a <u>licensed</u> professional art
- 21 therapist <u>licensed</u> under the provisions of this chapter;
- 22 (d) "Accredited institution" means a university or
- 23 college accredited by a nationally recognized accrediting agency

- of institutions of higher education, or an institution or clinical 24
- program approved by the American Art Therapy Association, Inc. 25
- SECTION 2. Section 73-65-3, Mississippi Code of 1972, is 26
- 27 amended as follows:[JU2]
- 73-65-3. (1) There is created the Professional Art 28
- Therapists Advisory Council. The purpose of the council is to 29
- 30 advise the State Board of Health on matters relating to the
- administration and interpretation of the provisions of this 31
- chapter. The council shall consist of three (3) members who are 32
- professional art therapists <u>licensed</u> pursuant to Section 73-65-7 33
- and who have engaged in art therapy practice for at least five (5) 34
- years and two (2) members shall be family members of consumers of 35
- 36 art therapy services. All council members shall be citizens of
- 37 the United States and residents of Mississippi. The initial
- council members who are not family members of consumers shall meet 38
- 39 requirements for <u>licensure</u> and be <u>licensed</u> within one (1) year
- after July 1, 2000. Beginning July 1, 2000, each council member 40
- who is not a family member of a consumer shall be <u>licensed</u> as an 41
- art therapist before appointment and shall be actively engaged in 42
- the practicing or teaching of art therapy. The initial council 43
- 44 members shall be appointed by the board for the following terms:
- one (1) member shall be appointed for a term of one (1) year; one 45
- 46 (1) member shall be appointed for a term of two (2) years; two (2)
- members shall be appointed for terms of three (3) years; and one 47
- (1) member shall be appointed for a term of four (4) years. After 48
- the expiration of the initial terms, all subsequent members of the 49
- 50 council shall be appointed by the board for terms of four (4)
- 51 years.
- Members of the council shall receive no compensation or 52
- 53 per diem for their service on the council, but may receive
- reimbursement for travel expenses incurred in attending council 54

- 55 meetings, as provided in Section 25-3-41.
- 56 (3) The council shall elect annually from its membership a
- 57 chairman and any other officers as necessary to carry out its
- 58 duties. The council shall meet at least two (2) times each year.
- 59 Additional meetings may be called by the chairman, upon the
- 60 written request of at least two (2) members of the council. Three
- 61 (3) council members shall constitute a quorum of the council.
- 62 SECTION 3. Section 73-65-5, Mississippi Code of 1972, is
- 63 amended as follows:[JU3]
- 64 73-65-5. The board shall:
- 65 (a) Promulgate regulations necessary to carry out the
- 66 provisions of this chapter;
- (b) Require that all applicants register for, take and
- 68 pass the national board certification exam as administered by the
- 69 Art Therapy Credentials Board of the American Art Therapy
- 70 Association;
- 71 (c) Establish the application deadline for and score
- 72 required to pass the examination;
- 73 (d) Process applications and conduct and review the
- 74 required examinations;
- 75 (e) Issue <u>licenses</u> to applicants who meet the
- 76 requirements of Sections 73-65-7 through 73-65-13;
- 77 (f) Deny, suspend, or revoke a <u>license</u> to practice art
- 78 therapy;
- 79 (g) Censure, reprimand, or place a <u>license</u> holder or
- 80 applicant on probation for a period not to exceed one (1) year;
- 81 (h) Maintain a current register of <u>license</u> holders as a
- 82 matter of public record;

- 83 (i) Establish criteria for continuing education;
- 84 (j) Establish procedures for receiving, investigating,
- 85 and resolving complaints against <u>license</u> holders;
- 86 (k) Approve the level of supervision and experience
- 87 required for persons seeking <u>licensure</u>;
- 88 (1) Assess fees for the issuance and renewal of
- 89 <u>licenses</u> to cover expenses of the board in administering this
- 90 chapter;
- 91 (m) Implement an impaired professional art therapist
- 92 treatment program; and
- 93 (n) Adopt a code of ethics as established by the
- 94 American Art Therapy Association.
- 95 SECTION 4. Section 73-65-7, Mississippi Code of 1972, is
- 96 amended as follows:[JU4]
- 97 73-65-7. (1) The board shall issue a <u>license</u> as a <u>licensed</u>
- 98 professional art therapist to any person who files a completed
- 99 application, accompanied by the required fees, and who submits
- 100 satisfactory evidence that the applicant is at least twenty-one
- 101 (21) years of age, demonstrates professional competency by
- 102 satisfactorily passing the required examination, is a registered
- 103 art therapist as defined by the Art Therapy Credentials Board,
- 104 Inc., is a <u>licensed</u> art therapist as defined by the Art Therapy
- 105 Credentials Board, Inc., and has:
- 106 (a) Received a master's degree or doctoral degree in
- 107 art therapy that includes six hundred (600) hours of supervised
- 108 internship experience from an accredited institution and has
- 109 completed an additional one thousand (1,000) client contact hours
- 110 of postgraduate experience under appropriate supervision; or

- 111 (b) Received a master's degree or doctoral degree in a
 112 related field, has a minimum of twenty-one (21) semester hours of
 113 sequential course work in the history, theory, and practice of art
 114 therapy, has completed seven hundred (700) hours of supervised
 115 internship experience from an accredited institution, and has
 116 completed an additional two thousand (2,000) client contact hours
 117 of postgraduate experience under appropriate supervision.
- 118 (2) The board may approve on a case-by-case basis applicants
 119 who have a master's degree or a doctoral degree from nonaccredited
 120 institutions.
- 121 (3) If an applicant has met all of the requirements for

 122 <u>licensure</u> except satisfactorily passing the required examination,

 123 the applicant shall be scheduled to take the next examination

 124 following the approval of the examination.
- (4) An applicant for <u>licensure</u> as a professional art
 therapist may be <u>licensed</u> without examination if the applicant
 files a completed application within one (1) year of July 1, 1998,
 accompanied by the required fees, and if the board determines that
 the applicant meets all other requirements for <u>licensure</u> as a
 professional art therapist.
- 131 (5) The board may issue a <u>license</u> to an applicant without
 132 examination if the person possesses a valid regulatory document
 133 issued by the appropriate examining board under the laws of any
 134 other state or territory of the United States, the District of
 135 Columbia, or any foreign nation that in the judgment of the board
 136 has requirements substantially equivalent to or exceeding the
 137 requirements in this section.
- 138 (6) The board may issue provisional <u>licensure</u> as a

- 139 professional art therapist to any person who has completed the
- 140 educational requirements in subsection (1)(a) or (1)(b) of this
- 141 section and is fulfilling the client contact hours requirement,
- 142 but has not taken the examination or received registration from
- 143 the American Art Therapy Association (ATR).
- 144 (7) The board may set criteria for continuing education and
- 145 supervisory experience.
- SECTION 5. Section 73-65-9, Mississippi Code of 1972, is
- 147 amended as follows:[JU5]
- 148 73-65-9. (1) Each <u>license</u> holder shall renew the <u>license</u> to
- 149 practice art therapy biennially by submitting a renewal
- 150 application on a form provided by the board, paying a <u>license</u>
- 151 renewal fee, and producing evidence of completion of relevant
- 152 professional continuing education experience satisfactory to the
- 153 board, not to exceed forty (40) hours per renewal cycle.
- 154 (2) A ninety-day grace period shall be allowed for each
- 155 <u>license</u> holder after the <u>licensure</u> period, during which time the
- 156 <u>license</u> may be renewed upon payment of the renewal fee, the late
- 157 fee, and compliance with all renewal requirements.
- 158 (3) Any <u>license</u> granted by the board shall be automatically
- 159 suspended if the holder fails to apply for the <u>license</u> renewal
- 160 pursuant to this section within a period of three (3) months after
- 161 the renewal deadline; however, any suspended <u>license</u> may be
- 162 restored by the board upon payment of a reinstatement fee not to
- 163 exceed One Hundred Dollars (\$100.00) in addition to any unpaid
- 164 renewal or late fees. Failure to renew a license within three (3)
- 165 months from the date of suspension as provided in this section
- 166 shall cause the <u>license</u> to be automatically revoked.

- 167 Reinstatement of a revoked <u>license</u> shall require the <u>license</u>
- 168 holder to reapply and meet all current standards for <u>licensure</u>.
- 169 (4) A person <u>licensed</u> under the provisions of Section
- 170 73-65-7 who intends to retire as a <u>licensed</u> professional art
- 171 therapist shall notify the board in writing before the expiration
- of his current <u>licensure</u>. If, within a period of five (5) years
- 173 from the year of retirement, the <u>license</u> holder wishes to resume
- 174 practice as a <u>licensed</u> professional art therapist, he shall notify
- 175 the board in writing, and upon giving proof of completing the
- 176 required continuing education and the payment of an amount
- 177 equivalent to elapsed renewal fees, the <u>license</u> shall be restored
- 178 in full effect.
- SECTION 6. Section 73-65-11, Mississippi Code of 1972, is
- 180 amended as follows:[JU6]
- 181 73-65-11. The board shall set the amount of the fees
- 182 required to be paid by applicants for <u>licensure</u> and <u>license</u>
- 183 holders including, but not limited to, the following:
- 184 (a) For an application for initial <u>licensure</u>, the fee
- 185 shall be nonrefundable and shall not exceed Two Hundred Dollars
- 186 (\$200.00);
- 187 (b) The renewal fee shall not exceed Two Hundred
- 188 Dollars (\$200.00);
- 189 (c) For a duplicate or replacement <u>license</u>, the fee
- 190 shall not exceed Twenty-five Dollars (\$25.00);
- 191 (d) For failure to renew a <u>license</u> within the allotted
- 192 grace period pursuant to Section 73-65-9, the fee shall not exceed
- 193 One Hundred Dollars (\$100.00); and
- (e) Other reasonable fees for administrative services.

- 195 SECTION 7. Section 73-65-13, Mississippi Code of 1972, is
- 196 amended as follows:[JU7]
- 197 73-65-13. (1) The board may deny any application, or
- 198 suspend or revoke any <u>license</u> held or applied for under the
- 199 provisions of Section 73-65-7 if the person:
- 200 (a) Is found guilty of fraud, deceit, or
- 201 misrepresentation in procuring or attempting to procure a <u>license</u>
- 202 to practice art therapy;
- 203 (b) Is adjudicated mentally incompetent;
- 204 (c) Is found guilty of a felony or misdemeanor
- 205 involving moral turpitude;
- 206 (d) Is found guilty of unprofessional or unethical
- 207 conduct in this or any other jurisdiction;
- 208 (e) Has been using any controlled substance or
- 209 alcoholic beverage to an extent or in a manner dangerous to the
- 210 person, any other person, or the public, or to an extent that the
- 211 use impairs the ability to perform as a <u>licensed</u> professional art
- 212 therapist;
- 213 (f) Has violated any provision of this chapter; or
- 214 (g) Willfully or negligently divulges a professional
- 215 confidence.
- 216 (2) A certified copy of the record of conviction shall be
- 217 conclusive evidence of the conviction.
- 218 (3) Disciplinary proceedings may be initiated upon the
- 219 receipt by the board of a sworn complaint by any person, including
- 220 members of the board.
- SECTION 8. Section 73-65-15, Mississippi Code of 1972, is
- 222 amended as follows:[JU8]

- 73-65-15. (1) The provisions of this chapter shall not
- 224 apply to persons licensed, certified, or registered under any
- 225 other provisions of Mississippi law, including, but not limited
- 226 to, physicians, social workers, psychologists, and nurses, or
- 227 students within accredited training programs of these professions.
- 228 The provisions of this chapter shall not apply to "activities
- 229 professionals" at licensed nursing facilities. Nothing in this
- 230 chapter shall be construed to limit, interfere with, or restrict
- 231 the practice, descriptions of services, or manner in which these
- 232 persons hold themselves out to the public.
- 233 (2) No person shall use the title "licensed professional art
- 234 therapist" or hold himself out as having this status, unless he is
- 235 <u>licensed</u> as such by the board.
- SECTION 9. Section 73-65-17, Mississippi Code of 1972, is
- 237 brought forward as follows: [JU9]
- 73-65-17. Any person who violates the provisions of this
- 239 chapter shall be guilty of a misdemeanor and, upon conviction
- 240 thereof, shall be fined not more than Five Hundred Dollars
- 241 (\$500.00), or sentenced to three (3) months in the county jail, or
- 242 both, for each violation.
- SECTION 10. Section 73-65-19, Mississippi Code of 1972,
- 244 which automatically repeals the Professional Art Therapists
- 245 Certification Law, is hereby repealed.
- 246 SECTION 11. This act shall take effect and be in force from
- 247 and after June 30, 2000.
