SENATE BILL NO. 2115

1 AN ACT MAKING AN APPROPRIATION OF STATE GENERAL FUNDS TO THE
2 DEPARTMENT OF WILDLIFE, FISHERIES AND PARKS FOR THE PURPOSE OF
3 PURCHASING FURNISHINGS AND EQUIPMENT FOR CERTAIN FACILITIES AT
4 VARIOUS STATE PARKS, FOR FISCAL YEAR 2001.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

6 SECTION 1. The following sum, or so much thereof as may be
7 necessary, is hereby appropriated out of any money in the State
8 General Fund not otherwise appropriated, to the Department of
9 Wildlife, Fisheries and Parks for the purpose of purchasing
10 furnishings and equipment at certain facilities at various state
11 parks for the fiscal year beginning July 1, 2000, and ending
12 June 30, 2001..... \$ 1,135,000.00.

13 SECTION 2. Of the funds appropriated under the provisions of
14 Section 1, it is the intention of the Legislature that funds shall
15 be allocated for furnishings and equipment for existing and new
16 cabins and facilities as follows:

53 SECTION 3. The money herein appropriated shall be paid by

54 the State Treasurer out of any money in the proper fund or funds
55 as set forth in this act, upon warrants issued by the State Fiscal
56 Officer; and the State Fiscal Officer shall issue his warrants
57 upon requisitions signed by the proper person, officer or officers
58 in the manner provided by law.

59 SECTION 4. This act shall take effect and be in force from
60 and after July 1, 2000.
