## SENATE BILL NO. 2317

AN ACT TO AMEND SECTION 43-33-115, MISSISSIPPI CODE OF 1972,

2 TO PROVIDE FOR THE APPOINTMENT OF ADDITIONAL REGIONAL HOUSING

3 AUTHORITY COMMISSIONERS; AND FOR RELATED PURPOSES.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 SECTION 1. Section 43-33-115, Mississippi Code of 1972, is

6 amended as follows:[RDD1]

7 43-33-115. The board of supervisors of each county included

8 in a regional housing authority shall appoint one (1) person as a

9 commissioner of such authority, and each such commissioner to be

10 first appointed by the board of supervisors of a county may be

11 appointed at or after the time of the adoption of the resolution

12 declaring the need for such regional housing authority or

13 declaring the need for the inclusion of such county in the area of

14 operation of such regional housing authority. When the area of

15 operation of a regional housing authority is increased to include

16 an additional county or counties as provided above, the board of

17 supervisors of each such county shall thereupon appoint one (1)

18 additional person as a commissioner of the regional housing

19 authority. The board of supervisors of each county shall appoint

20 the successor of the commissioner appointed by it. A certificate

21 of the appointment of any such commissioner shall be filed with

22 the clerk of the county, and such certificate shall be conclusive

23 evidence of the due and proper appointment of such commissioner.

24 If any county is excluded from the area of operation of a regional

25 housing authority, the office of the commissioner of such regional

26 housing authority appointed by the board of supervisors of such

27 county shall be thereupon abolished.

If the area of operation of a regional housing authority
consists at any time of an even number of counties, the
commissioners of the regional housing authority appointed by the
boards of supervisors of such counties shall appoint up to three

(3) additional commissioners whose term of office shall be as

herein provided for a commissioner of a regional housing authority

except that such term shall end at any earlier time that the area

of operation of the regional housing authority shall be changed to

36 consist of an odd number of counties, it being the intent at all

37 <u>times to have an odd number of commissioners for such regional</u>

38 <u>housing authority</u>. <u>If the area of operation of a regional</u>

39 housing authority consists at any time of an odd number of

counties, the commissioners of the regional housing authority

41 appointed by the boards of supervisors of such counties shall have

42 the authority to appoint two (2) additional commissioners whose

43 terms of office shall be as herein provided for a commissioner of

44 <u>a regional housing authority</u>. The commissioners of such authority

appointed by the boards of supervisors of such counties shall

46 likewise appoint each person to succeed such additional

47 commissioner or commissioners; the term of office of such person

48 or persons begins during the terms of office of the commissioner

49 appointing him. A certificate of the appointment of any such

50 additional commissioner or commissioners of such regional housing

51 authority shall be filed with the other records of the regional

52 housing authority and shall be conclusive evidence of the due and

- 53 proper appointment of such additional commissioner or
- 54 commissioners.
- The commissioners of a regional housing authority shall be
- 56 appointed for terms of five (5) years except that all vacancies
- 57 shall be filled for the unexpired terms. Each commissioner shall
- 58 hold office until his successor has been appointed and has
- 59 qualified, except as otherwise provided herein.
- The commissioners shall constitute the regional housing
- 61 authority, and the powers of such authority shall be vested in
- 62 such commissioners in office from time to time.
- The commissioners of a regional housing authority shall elect
- 64 a chairman from among the commissioners and shall have power to
- 65 select or employ such other officers and employees as the regional
- 66 housing authority may require. A majority of the commissioners of
- 67 a regional housing authority shall constitute a quorum of such
- 68 authority for the purpose of conducting its business and
- 69 exercising its powers and for all other purposes.
- 70 SECTION 2. This act shall take effect and be in force from
- 71 and after July 1, 2000.
