SENATE BILL NO. 2403

AN ACT TO AMEND SECTION 25-55-25, MISSISSIPPI CODE OF 1972,

2 TO REMOVE THE PROVISION THAT PROHIBITS DUPLICATES OF LOST OR

3 DESTROYED WARRANTS FROM BEING ISSUED UNTIL AN AFFIDAVIT AND A BOND

4 ARE FILED WITH THE OFFICER ISSUING THE DUPLICATE; TO AMEND SECTION

5 25-55-27, MISSISSIPPI CODE OF 1972, IN CONFORMITY THERETO; AND FOR

6 RELATED PURPOSES.

- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 8 SECTION 1. Section 25-55-25, Mississippi Code of 1972, is
- 9 amended as follows:[WAN1]
- 10 25-55-25. A duplicate for a lost or destroyed bond * * *
- 11 shall not issue until there shall have been filed with the officer
- 12 an affidavit and a bond. The affidavit must be that of some
- 13 credible person knowing the facts, and it must set forth the
- 14 ownership of such bond * * * the number of unpaid coupons, if any,
- 15 thereto attached, and the description thereof, embracing, if can
- 16 be, its number, to whom and for what issued, its date, and when
- 17 mature. The bond must be that of a person to whom the duplicate
- 18 is to be issued, with at least two (2) sufficient sureties, in a
- 19 sum equal to double the amount of the lost, destroyed or stolen
- 20 bond * * * payable to the state, conditioned to pay all damages
- 21 which the state, county, city, town, or levee board, as the case
- 22 may be, may sustain if compelled to pay such bond or coupons * * *
- 23 together with all costs and expenses and lawyers' fees, if any,

- 24 incurred in enforcing the bond.
- 25 SECTION 2. Section 25-55-27, Mississippi Code of 1972, is
- 26 amended as follows:[WAN2]
- 27 25-55-27. Any officer issuing duplicates of bonds or
- 28 warrants shall keep a record showing:
- 29 <u>(a)</u> The numbers, dates and amounts of such mutilated,
- 30 lost or destroyed bonds or warrants and of the coupons thereto
- 31 attached<u>;</u>
- 32 (b) * * * The date of the issuance of the
- 33 duplicate; * * *
- 34 (c) The name of the person to whom the duplicate was
- 35 issued; and
- 36 <u>(d) The name</u> of the sureties and penalty of the
- 37 indemnity bond, if a bond is required.
- 38 <u>The officer issuing duplicates of bonds</u> shall preserve the
- 39 bond and affidavit taken in each case.
- 40 SECTION 3. This act shall take effect and be in force from
- 41 and after July 1, 2000.
