SENATE BILL NO. 2432 (As Sent to Governor)

AN ACT RELATING TO THE REGULATION OF CERTAIN FOOD LAWS BY THE STATE BOARD OF HEALTH; TO REPEAL SECTIONS 75-29-301 THROUGH 1 2 75-29-315, MISSISSIPPI CODE OF 1972, WHICH IS THE "DEGERMINATED 3 CORN MEAL AND GRITS LAW"; TO REPEAL SECTIONS 75-29-401 THROUGH 4 75-29-415, MISSISSIPPI CODE OF 1972, WHICH IS THE "FLOUR AND BREAD ENRICHMENT LAW"; TO REPEAL SECTIONS 75-29-501 THROUGH 75-29-511, MISSISSIPPI CODE OF 1972, WHICH IS THE "OLEOMARGARINE ENRICHMENT LAW"; TO REPEAL SECTIONS 75-37-1 THROUGH 75-37-35, MISSISSIPPI 5 6 7 8 CODE OF 1972, WHICH IS THE "FROZEN FOOD LOCKER PLANT LAW"; AND FOR 9 10 RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 SECTION 1. Sections 75-29-301, 75-29-303, 75-29-305, 12 13 75-29-307, 75-29-309, 75-29-311, 75-29-313 and 75-29-315, Mississippi Code of 1972, which is the "Degerminated Corn Meal and 14 15 Grits Law, " are hereby repealed. SECTION 2. Sections 75-29-401, 75-29-403, 75-29-405, 16 75-29-407, 75-29-409, 75-29-411, 75-29-413 and 75-29-415, 17 Mississippi Code of 1972, which is the "Flour and Bread Enrichment 18 19 Law," are hereby repealed. SECTION 3. Sections 75-29-501, 75-29-503, 75-29-505, 20 75-29-507, 75-29-509 and 75-29-511, Mississippi Code of 1972, 21 22 which is the "Oleomargarine Enrichment Law," are hereby repealed. 23 SECTION 4. Sections 75-37-1, 75-37-3, 75-37-5, 75-37-7, 75-37-9, 75-37-11, 75-37-13, 75-37-15, 75-37-17, 75-37-19, 24 75-37-21, 75-37-23, 75-37-25, 75-37-27, 75-37-29, 75-37-31, 25 75-37-33 and 75-37-35, Mississippi Code of 1972, which is the 26 27 "Frozen Food Locker Plant Law," are hereby repealed. 28 SECTION 5. This act shall take effect and be in force from 29 and after July 1, 2000.
