SENATE BILL NO. 2449

- AN ACT TO AMEND SECTION 25-4-105, MISSISSIPPI CODE OF 1972,
- 2 TO ALLOW A COUNTY EMPLOYEE TO SERVE AS A CONSTABLE OF THE COUNTY
- 3 EMPLOYING HIM; AND FOR RELATED PURPOSES.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 SECTION 1. Section 25-4-105, Mississippi Code of 1972, is
- 6 amended as follows:[CSQ1]
- 7 25-4-105. (1) No public servant shall use his official
- 8 position to obtain pecuniary benefit for himself other than that
- 9 compensation provided for by law, or to obtain pecuniary benefit
- 10 for any relative or any business with which he is associated.
- 11 (2) No public servant shall be interested, directly or
- 12 indirectly, during the term for which he shall have been chosen,
- 13 or within one (1) year after the expiration of such term, in any
- 14 contract with the state, or any district, county, city or town
- 15 thereof, authorized by any law passed or order made by any board
- 16 of which he may be or may have been a member.
- 17 (3) No public servant shall:
- 18 (a) Be a contractor, subcontractor or vendor with the
- 19 governmental entity of which he is a member, officer, employee or
- 20 agent, other than in his contract of employment, or have a
- 21 material financial interest in any business which is a contractor,

- 22 subcontractor or vendor with the governmental entity of which he
- 23 is a member, officer, employee or agent.
- 24 (b) Be a purchaser, direct or indirect, at any sale
- 25 made by him in his official capacity or by the governmental entity
- of which he is an officer or employee, except in respect of the
- 27 sale of goods or services when provided as public utilities or
- 28 offered to the general public on a uniform price schedule.
- 29 (c) Be a purchaser, direct or indirect, of any claim,
- 30 certificate, warrant or other security issued by or to be paid out
- 31 of the treasury of the governmental entity of which he is an
- 32 officer or employee.
- 33 (d) Perform any service for any compensation during his
- 34 term of office or employment by which he attempts to influence a
- 35 decision of the authority of the governmental entity of which he
- 36 is a member.
- 37 (e) Perform any service for any compensation for any
- 38 person or business after termination of his office or employment
- 39 in relation to any case, decision, proceeding or application with
- 40 respect to which he was directly concerned or in which he
- 41 personally participated during the period of his service or
- 42 employment.
- 43 (4) Notwithstanding the provisions of subsection (3) of this
- 44 section, a public servant or his relative:
- 45 (a) May be an officer or stockholder of banks or
- 46 savings and loan associations or other such financial institutions
- 47 bidding for bonds, notes or other evidences of debt or for the
- 48 privilege of keeping as depositories the public funds of a
- 49 governmental entity thereof or the editor or employee of any
- 50 newspaper in which legal notices are required to be published in
- 51 respect to the publication of said legal notices.
- 52 (b) May be a contractor or vendor with any authority of

53 the governmental entity other than the authority of the 54 governmental entity of which he is a member, officer, employee or 55 agent or have a material financial interest in a business which is 56 a contractor or vendor with any authority of the governmental 57 entity other than the authority of the governmental entity of which he is a member, officer, employee or agent where such 58 contract is let to the lowest and best bidder after competitive 59 bidding and three (3) or more legitimate bids are received or 60 where the goods, services or property involved are reasonably 61 62 available from two (2) or fewer commercial sources, provided such

transactions comply with the public purchases laws.

64 (c) May be a subcontractor with any authority of the governmental entity other than the authority of the governmental 65 entity of which he is a member, officer, employee or agent or have 66 67 a material financial interest in a business which is a subcontractor with any authority of the governmental entity other 68 69 than the authority of the governmental entity of which he is a 70 member, officer, employee or agent where the primary contract is let to the lowest and best bidder after competitive bidding or 71 72 where such goods or services involved are reasonably available from two (2) or fewer commercial sources, provided such 73 74 transactions comply with the public purchases laws.

(d) May be a contractor, subcontractor or vendor with any authority of the governmental entity of which he is a member, officer, employee or agent or have a material financial interest in a business which is a contractor, subcontractor or vendor with any authority of the governmental entity of which he is a member, officer, employee or agent: (i) where such goods or services

- 81 involved are reasonably available from two (2) or fewer commercial
- 82 sources, provided such transactions comply with the public
- 83 purchases laws; or (ii) where the contractual relationship
- 84 involves the further research, development, testing, promotion or
- 85 merchandising of an intellectual property created by the public
- 86 servant.
- 87 (e) May purchase securities issued by the governmental
- 88 entity of which he is an officer or employee if such securities
- 89 are offered to the general public and are purchased at the same
- 90 price as such securities are offered to the general public.
- 91 (f) May have an interest less than a material financial
- 92 interest in a business which is a contractor, subcontractor or
- 93 vendor with any governmental entity.
- 94 (g) May contract with the Mississippi Veteran's Home
- 95 Purchase Board, Mississippi Housing Finance Corporation, or any
- 96 other state loan program, for the purpose of securing a loan;
- 97 however, public servants shall not receive favored treatment.
- 98 (h) May be employed by or receive compensation from an
- 99 authority of the governmental entity other than the authority of
- 100 the governmental entity of which the public servant is an officer
- 101 or employee.
- 102 (i) If a member of the Legislature or other public
- 103 servant employed on less than a full-time basis, may represent a
- 104 person or organization for compensation before an authority of the
- 105 governmental entity other than an authority of the governmental
- 106 entity of which he is an officer or employee.
- 107 (j) If a constable, may be employed and receive
- 108 compensation as a deputy sheriff or other employee of the county

- 109 for which he serves as constable.
- 110 (5) No person may intentionally use or disclose information
- 111 gained in the course of or by reason of his official position or
- 112 employment as a public servant in any way that could result in
- 113 pecuniary benefit for himself, any relative, or any other person,
- 114 if the information has not been communicated to the public or is
- 115 not public information.
- 116 (6) Any contract made in violation of this section may be
- 117 declared void by the governing body of the contracting or selling
- 118 authority of the governmental subdivision or a court of competent
- 119 jurisdiction and the contractor or subcontractor shall retain or
- 120 receive only the reasonable value, with no increment for profit or
- 121 commission, of the property or the services furnished prior to the
- 122 date of receiving notice that the contract has been voided.
- 123 (7) Any person violating the provisions of this section
- 124 shall be punished as provided for in Sections 25-4-109 and
- 125 25-4-111.
- 126 SECTION 2. This act shall take effect and be in force from
- 127 and after July 1, 2000.
