- 2 AUTHORIZE EXPENSE REIMBURSEMENT AND MILEAGE FOR MEMBERS OF THE
- 3 MISSISSIPPI CIVIL WAR BATTLEFIELD COMMISSION; AND FOR RELATED
- 4 PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 SECTION 1. Section 39-5-91, Mississippi Code of 1972, is
- 7 amended as follows:[LR1]
- 8 39-5-91. (1) There is hereby created a Mississippi Civil
- 9 War Battlefield Commission consisting of the following fifteen
- 10 (15) members:
- 11 (a) Nine (9) members appointed by the Governor with
- 12 three (3) serving for an initial term concluding on March 1, 1998,
- 13 three (3) serving for an initial term concluding on March 1, 2000,
- 14 and three (3) serving for an initial term concluding on March 1,
- 15 2002;
- 16 (b) One (1) member appointed by the Lieutenant Governor
- 17 for an initial term concluding on March 1, 2002;
- 18 (c) One (1) member appointed by the Speaker of the
- 19 Mississippi House of Representatives for an initial term
- 20 concluding on March 1, 2002;
- 21 (d) One (1) member appointed by the Jackson Civil War
- 22 Roundtable for an initial term concluding on March 1, 2002; and

(e) Three (3) members appointed by the Board of

24 Trustees of the Department of Archives and History for an initial

- 25 term concluding on March 1, 2002.
- 26 After the initial terms, all terms shall be for six (6)
- 27 years. An appointment to fill a vacancy which arises for reasons
- 28 other than by expiration of a term of office shall be made by the
- 29 respective appointing authority for the unexpired term only.
- 30 (2) The commission shall elect from its membership a
- 31 chairman who shall preside over meetings and a vice chairman who
- 32 shall preside in the absence of the chairman or when the chairman
- 33 shall be excused.
- 34 (3) The commission shall adopt rules and regulations
- 35 governing times and places for meetings. A majority of members of
- 36 the commission shall constitute a quorum for the transaction of
- 37 any business. The commission shall meet at least quarterly. The
- 38 commission may form subcommittees to address specific issues
- 39 concerning preservation and enhancement of Civil War sites and
- 40 structures. The commission may adopt other procedures necessary
- 41 to ensure the orderly transaction of business.
- 42 (4) The members of the commission shall receive no
- 43 compensation for their services, but shall receive reimbursement
- 44 for actual expenses and mileage incurred in attending necessary
- 45 <u>business of the commission, as authorized by law</u>.
- 46 (5) Principal staff support for the commission shall be
- 47 provided by the Department of Archives and History. Other
- 48 agencies shall assist when requested by the commission.
- 49 (6) The commission shall have the following duties:
- 50 (a) Identify and prioritize for protecting
- 51 Mississippi's Civil War sites and structures;
- 52 (b) Identify, analyze and enhance preservation
- 53 opportunities for Mississippi's Civil War sites and structures;

- 54 (c) Review existing local, state and federal plans,
- 55 programs and policies related to Mississippi's Civil War sites and
- 56 structures;
- 57 (d) Develop relationships with federal and local
- 58 officials and private conservation organizations which facilitate
- 59 protection and enhancement of Civil War sites and structures;
- (e) Coordinate Mississippi's participation with the
- 61 federal government and private foundations to secure support and
- 62 financial resources for the protection and enhancement of Civil
- 63 War sites and structures;
- (f) Advise state agencies on matters relating to Civil
- 65 War sites and structures; and
- 66 (g) Perform any other such duties or actions in an
- 67 effort to advance Civil War history in Mississippi.
- 68 (7) The commission shall submit to the Governor an annual
- 69 report by December 1 of each year which shall include
- 70 recommendations for any legislative, administrative or other
- 71 changes the commission deems necessary to further Civil War
- 72 history in Mississippi.
- 73 (8) State agencies shall consider the impact of their
- 74 actions on Civil War sites and structures as identified by the
- 75 commission whenever permitting, planning, funding or undertaking
- 76 any construction projects.
- 77 SECTION 2. This act shall take effect and be in force from
- 78 and after July 1, 2000.
