SENATE BILL NO. 2621 (As Sent to Governor)

AN ACT TO AMEND SECTION 19-11-7, MISSISSIPPI CODE OF 1972, TO REVISE THE DATE FOR PUBLICATION OF THE COUNTY BUDGET; AND FOR 1 2 3 RELATED PURPOSES. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. Section 19-11-7, Mississippi Code of 1972, is 6 amended as follows: 7 [With regard to any county which is exempt from the provisions of Section 19-2-3, this section shall read as follows:] 8 9 19-11-7. The board of supervisors of each county of the State of Mississippi shall, at its August meeting of each year, 10 prepare a complete budget of revenues, expenses and a working cash 11 12 balance estimated for the next fiscal year, which shall be based 13 on the aggregate funds estimated to be available for the ensuing fiscal year for each fund, from which such estimated expenses will 14 be paid, exclusive of school maintenance funds, which shall be 15 shown separately. Such statement of revenues shall show every 16 source of revenue along with the amount derived from each source. 17 The budget containing such statement of revenues and expenses 18 shall be published at least one (1) time during August or 19 20 September but not later than September 30 of the year in a newspaper published in the county, or if no newspaper is published 21 22 therein, then in a newspaper having a general circulation therein. [With regard to any county which is required to operate on a 23 countywide system of road administration as described in Section 24 19-2-3, this section shall read as follows:] 25

19-11-7. The county administrator of each county of the

- 28 supervisors at its August meeting of each year a complete budget
- 29 of revenues, expenses and a working cash balance estimated for the
- 30 next fiscal year, which shall be based on the aggregate funds
- 31 estimated to be available for the ensuing fiscal year for each
- 32 fund, from which such estimated expenses will be paid, exclusive
- 33 of school maintenance funds, which shall be shown separately and
- 34 exclusive of the budget of the sheriff's department which shall be
- 35 prepared by the sheriff. Such statement of revenues shall show
- 36 every source of revenue along with the amount derived from each
- 37 source. The budget, including the sheriff's budget, containing
- 38 <u>such</u> statement of revenues and expenses shall be published at
- 39 least one (1) time during August or September but not later than
- 40 September 30 of the year in a newspaper published in the county,
- 41 or if no newspaper is published therein, then in a newspaper
- 42 having a general circulation therein.
- 43 SECTION 2. This act shall take effect and be in force from
- 44 and after July 1, 2000.
