SENATE BILL NO. 2779

1 AN ACT TO AMEND SECTION 25-3-33, MISSISSIPPI CODE OF 1972, TO  
2 PROVIDE THAT THE STATE VETERANS AFFAIRS BOARD SHALL ESTABLISH THE  
3 SALARIES OF THE EXECUTIVE DIRECTOR AND DEPUTY DIRECTOR OF THE  
4 BOARD WITHIN THE RANGE SET BY THE STATE PERSONNEL BOARD; TO  
5 PROVIDE THAT THE STATE VETERANS HOME PURCHASE BOARD SHALL  
6 ESTABLISH THE SALARY OF THE EXECUTIVE OFFICER OF THE BOARD WITHIN  
7 THE RANGE SET BY THE STATE PERSONNEL BOARD; AND FOR RELATED  
8 PURPOSES.

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

10 SECTION 1. Section 25-3-33, Mississippi Code of 1972, is  
11 amended as follows:[JMR1]
