SENATE BILL NO. 2815

AN ACT TO REQUIRE RETAILERS OF ALCOHOLIC BEVERAGES, BEER AND LIGHT WINES TO DISPLAY SIGNS ON THE PREMISES WHERE THE ALCOHOLIC 1 2 3 BEVERAGES ARE SOLD THAT INFORM THE PUBLIC THAT DRINKING ALCOHOLIC BEVERAGES DURING PREGNANCY CAN CAUSE BIRTH DEFECTS; AND FOR 4 5 RELATED PURPOSES. б BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. Each holder of a package retailer's permit, 8 on-premises retailer's permit or native wine retailer's permit 9 shall display on the premises where the permittee sells alcoholic 10 beverages at least one (1) sign that reads substantially as 11 follows: "WARNING! DRINKING WINE, BEER OR OTHER ALCOHOLIC BEVERAGES DURING PREGNANCY CAN CAUSE BIRTH DEFECTS. " Any and all 12 13 advertising of alcoholic beverages must contain the following 14 "WARNING! DRINKING WINE, BEER OR OTHER ALCOHOLIC message: 15 BEVERAGES DURING PREGNANCY CAN CAUSE BIRTH DEFECTS." All medical facilities where treatment or advice is given during pregnancy, 16 whether such facility is a private business or residence 17 establishment, a sign will be posted on each floor of the business 18 as near the entrance as possible the following message: "WARNING! 19 DRINKING WINE, BEER OR OTHER ALCOHOLIC BEVERAGES DURING PREGNANCY 20 CAN CAUSE BIRTH DEFECTS. " The sign or signs shall be at least 21 fifteen (15) inches wide and fifteen (15) inches long with 2.2 lettering not less than one (1) inch in height, and one (1) sign 23 must be easily visible from the location in the premises where the 2.4 consumer purchases or otherwise receives the alcoholic beverages. 25

26 <u>SECTION 2.</u> Each holder of a permit or privilege license to 27 engage in the business of a retailer of beer or light wines shall

display on the premises where the permittee or licensee sells beer 28 29 or light wines at least one (1) sign that reads substantially as 30 follows: "WARNING! DRINKING WINE, BEER OR OTHER ALCOHOLIC BEVERAGES DURING PREGNANCY CAN CAUSE BIRTH DEFECTS. " The sign or 31 32 signs shall be at least fifteen (15) inches wide and fifteen (15) inches long with lettering not less than one (1) inch in height, 33 and one (1) sign must be easily visible from the location in the 34 premises where the consumer purchases or otherwise receives the 35 beer or light wines. 36

Any person who fails to comply with the requirements of this section shall be subject to a fine of Twenty-five Dollars (\$25.00) if convicted and upon conviction be guilty of a misdemeanor. However, if a person remedies such noncompliance by the time of the person's scheduled court appearance, all charges shall be dismissed against such person.

43 SECTION 3. Section 1 shall be codified as a new section in 44 Chapter 1 of Title 67, Mississippi Code of 1972; Section 2 shall 45 be codified as a new section in Chapter 3 of Title 67, Mississippi 46 Code of 1972.

47 SECTION 4. This act shall take effect and be in force from 48 and after July 1, 2000.
