## SENATE BILL NO. 2937 (As Passed the Senate)

AN ACT TO REENACT AND AMEND SECTION 37-159-11, MISSISSIPPI 1 CODE OF 1972, WHICH ESTABLISHES THE MISSISSIPPI EMPLOYER-ASSISTED 3 HOUSING TEACHER PROGRAM THAT PROVIDES INTEREST-FREE LOANS TO LICENSED TEACHERS IN CRITICAL TEACHER SHORTAGE AREAS, TO EXTEND 5 THE REPEALER ON THAT SECTION; AND FOR RELATED PURPOSES. 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. Section 37-159-11, Mississippi Code of 1972, is reenacted and amended as follows:[BD1] 37-159-11. (1) There is established the Mississippi 9 10 Employer-Assisted Housing Teacher Program, which shall be a special home loan program for eligible licensed teachers who 11 render service to the state in a geographical area of the state 12 13 where there exists a critical shortage of teachers, as designated 14 by the State Board of Education. The home loan program shall be administered by the State Department of Education in conjunction 15 16 with the Federal National Mortgage Association (Fannie Mae). The department may contract with one or more public or private 17 entities to provide assistance in implementing and administering 18 the program. The State Board of Education shall adopt rules and 19 regulations regarding the implementation and administration of the 20 21 program. Participation in the loan program shall be available to 2.2
