## SENATE BILL NO. 2976

- AN ACT TO CREATE A NEW SECTION TO BE CODIFIED AS SECTION 27-19-56.15, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE LICENSE TAGS IN SUPPORT OF KEEP MISSISSIPPI 3 BEAUTIFUL, INC.; TO PRESCRIBE CERTAIN ADDITIONAL FEES THAT SHALL BE COLLECTED FOR THE LICENSE TAGS; TO PROVIDE THAT THE ADDITIONAL 5 FEES SHALL BE DEPOSITED IN THE STATEWIDE LITTER PREVENTION FUND CREATED UNDER SECTION 65-1-167; AND FOR RELATED PURPOSES. 6 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 SECTION 1. The following shall be codified as Section 27-19-56.15, Mississippi Code of 1972: 10 27-19-56.15. (1) Owners of motor vehicles who are residents 11 of this state, upon complying with the motor vehicle laws relating 12 to registration and licensing of motor vehicles, and upon payment 13 14 of the road and bridge privilege taxes, ad valorem taxes and 15 registration fees as prescribed by law for private carriers of passengers, pickup trucks and other noncommercial motor vehicles, 16 17 and upon payment of an additional fee in the amount provided in subsection (3) of this section, shall be issued a distinctive 18 license tag in recognition of their support for Keep Mississippi 19 20 Beautiful, Inc. The distinctive license tags so issued shall be of such color and design as may be determined finally by the State 21 22 Tax Commission based upon three (3) recommendations presented to the State Tax Commission by the Keep Mississippi Beautiful, Inc. 23 24 and ranked in order of preference by the Keep Mississippi
- 26 (2) Application for the distinctive license tags authorized 27 by this section shall be made to the county tax collector on forms 28 prescribed by the State Tax Commission. The application and the

29 additional fee imposed under subsection (3) of this section, plus

30 Two Dollars (\$2.00) thereof to be retained by the tax collector as

- 31 a processing fee, shall be remitted to the State Tax Commission
- 32 within seven (7) days of the date the application is made. The
- 33 portion of the additional fee retained by the tax collector shall
- 34 be deposited into the county general fund. Distinctive license
- 35 tags issued under this section shall be issued within forty-five
- 36 (45) days after application is made.
- 37 (3) Beginning with any registration year commencing on or
- 38 after July 1, 2000, any person applying for a distinctive license
- 39 tag under this section shall pay an additional fee in the amount
- 40 of Twenty Dollars (\$20.00) for each distinctive license tag
- 41 applied for under this section which shall be in addition to all
- 42 other taxes and fees. The additional fee paid shall be for a
- 43 period of time to run concurrent with the vehicle's established
- 44 license tag year. The additional fee is due and payable at the
- 45 time the original application is made for a distinctive license

- 48 license tag. If the owner does not wish to retain the distinctive

- 52 on another vehicle as otherwise provided by law. Distinctive
- 53 license tags issued under this section may be transferred by the
- 54 owner to any other vehicle owned by the person upon payment of the
- 55 regular taxes and fees for a license tag for that vehicle.
- 56 (4) The State Tax Commission shall deposit all fees into the
- 57 State Treasury on the day collected. At the end of each month,
- 58 the State Tax Commission shall certify to the State Treasurer the
- 59 total fees collected under this section from the issuance of
- 60 distinctive license tags. The State Treasurer shall distribute an
- 61 amount equal to Twenty Dollars (\$20.00) of the additional fees
- 62 collected for each such distinctive license tag issued under this
- 63 section to the statewide litter prevention fund created under
- 64 Section 65-1-167. Monies in the special fund, upon legislative
- 65 appropriation, may be expended or provided in Section 65-1-167.

66 (5) A regular license tag must be properly displayed as
67 required by law until replaced by a distinctive license tag under
68 this section. The regular license tag must be surrendered to the
69 tax collector upon issuance of the distinctive license tag under
70 this section. The tax collector shall issue up to two (2) license
71 decals for each distinctive license tag issued under this section,
72 which will expire the same month and year as the regular license

74 (6) In the case of loss or theft of a distinctive license 75 tag issued under this section, the owner may make application and affidavit for a replacement distinctive license tag as provided by 76 Section 27-19-37. The fee for a replacement distinctive license 77 tag shall be Ten Dollars (\$10.00). The tax collector receiving 78 79 such application and affidavit shall be entitled to retain and deposit in the county general fund five percent (5%) of the fee 80 81 for such replacement license tag and the remainder shall be 82 distributed in the same manner as funds from the sale of regular distinctive license tags issued under this section. 83

SECTION 2. This act shall take effect and be in force from and after July 1, 2000.
