SENATE BILL NO. 3082

AN ACT TO AMEND SECTIONS 7-9-151, 7-9-153 and 7-9-155, 1 2 MISSISSIPPI CODE OF 1972, TO REVISE THE PURPOSES FOR WHICH FUNDS 3 IN THE CAPITAL IMPROVEMENTS PREPLANNING FUND MAY BE EXPENDED; TO 4 INCREASE THE AMOUNT OF FUNDS THAT MAY BE EXPENDED ON THE 5 PREPLANNING OF A PROJECT; AND FOR RELATED PURPOSES. б BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. Section 7-9-151, Mississippi Code of 1972, is 8 amended as follows:[LH1] 7-9-151. There is hereby established in the State Treasury a 9 10 revolving fund to be designated as the "Capital Improvements 11 Preplanning Fund" which shall consist of monies appropriated or otherwise made available therefor by the Legislature. Such funds 12 13 as may be deposited in the revolving fund may be expended by the 14 Bureau of Building, Grounds and Real Property Management to obtain preliminary studies, plans, appraisals, and the purchase of 15 16 options on or the acquisition of real property. The bureau shall consider architectural and aesthetic compatibility in the 17 preplanning of any project conducted using money from the Capital 18 Improvements Preplanning Fund. 19 SECTION 2. Section 7-9-153, Mississippi Code of 1972, is 20 21 amended as follows:[LH2] 22 7-9-153. All expenses for preplanning projects authorized by 23 the Legislature shall be paid upon warrants drawn on the Capital Improvement Preplanning Fund created pursuant to this act. 2.4 The Department of Finance and Administration shall issue warrants upon 25 requisitions signed by the Director of the Bureau of Building, 26 Grounds and Real Property Management. Such requisitions shall set 27

S. B. No. 3082 00\SS03\R1344 PAGE 1 forth the name of the project and estimated cost of the project, and the total of prior expenditures for such project. The Department of Finance and Administration shall not issue a warrant against the Capital Improvements Preplanning Fund if the total amount expended for preliminary study and planning on the project, <u>excluding the acquisition cost of real property</u>, exceeds <u>five</u> percent (5%) of the estimated cost of such project.

35 SECTION 3. Section 7-9-155, Mississippi Code of 1972, is 36 amended as follows:[LH3]

7-9-155. Upon the appropriation of funds or the sale of 37 bonds to fund any project authorized by the Legislature for which 38 planning funds have been expended under the provisions of this 39 act, the Director of the Bureau of Building, Grounds and Real 40 Property Management shall requisition such amount as has been 41 expended for preliminary planning to be transferred from the 42 43 available funds for such project to the Capital Improvements Preplanning Fund and the Department of Finance and Administration 44 45 shall make such transfer.

46 SECTION 4. This act shall take effect and be in force from 47 and after its passage.
