COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 3166

AN ACT TO AMEND SECTION 57-63-11, MISSISSIPPI CODE OF 1972, TO MAKE THE VICE PRESIDENT FOR AGRICULTURE, FORESTRY AND 3 VETERINARY MEDICINE AT MISSISSIPPI STATE UNIVERSITY AND THE CHAIRMAN OF THE DEPARTMENT OF AGRICULTURE AT ALCORN STATE 5 UNIVERSITY MEMBERS OF THE SPECIAL TASK FORCE FOR ECONOMIC DEVELOPMENT PLANNING; TO REQUIRE THE HEADS OF THE STATE 6 INSTITUTIONS OF HIGHER LEARNING TO ASSIST THE SPECIAL TASK FORCE 7 FOR ECONOMIC DEVELOPMENT PLANNING IN AN ADVISORY CAPACITY AND TO 8 9 MEET WITH THE TASK FORCE AT LEAST ONCE ANNUALLY; AND FOR RELATED 10 PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 SECTION 1. Section 57-63-11, Mississippi Code of 1972, is 12 13 amended as follows: 57-63-11. (1) The Special Task Force for Economic 14 15 Development Planning, to consist of not more than <u>twenty-five (25)</u> members, is hereby created. The task force shall be composed of: 16 (a) One (1) member from the state's public universities 17 and one (1) member from the state's junior colleges. These 18 19 members shall be selected by the Governor. 20 (b) One (1) member from the membership or staffs of each of the following organizations: Mississippi Association of 21 22 Supervisors, Mississippi Municipal Association, Mississippi 23 Association of Planning and Development Districts, and the Mississippi Industrial Development Council. These members will be 24 25 appointed to the task force by the Governor from recommendations 26 made to the board by the respective organizations.

The Executive Officer of the State Board of Health.

The State Superintendent of Education.

- 44 and/or professional enterprises in Mississippi; two (2) of the
- 45 eight (8) members may be representative of business or
- 46 professional enterprises residing outside Mississippi and may
- 47 include foreign nationals.
- 48 (2) The heads of the state institutions of higher learning
- 49 shall assist the task force in an advisory capacity and shall meet
- 50 with the task force at least once annually.
- 51 (3) It is the intent of the Legislature that the task force
- 52 will be organized, selected and constituted in such a way that it
- 53 represents the most talented individuals that could possibly be
- 54 assembled to address the economic development concerns and issues
- of this state. Task Force members shall be appointed by July 1,
- 56 1987, and the Task Force shall have its organizational meeting no
- 57 later than August 1, 1987. The Governor shall designate from the
- 58 task force membership a task force chairman. Terms of service of
- 59 task force members shall coincide with the remaining term of the
- 60 Governor who makes the appointment.
- 61 SECTION 2. This act shall take effect and be in force from
- 62 and after July 1, 2000.
