4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the support and
8	maintenance of the Alcorn State University Agricultural Programs
9	for the fiscal year beginning July 1, 2000, and ending
LO	June 30, 2001\$ 5,290,751.00.
L1	SECTION 2. The following sum, or so much thereof as may be
L2	necessary, is hereby authorized for expenditure out of any special
L3	source funds which are collected by or otherwise become available,
L4	for the support and maintenance of the Alcorn State University
L5	Agricultural Programs for the fiscal year beginning July 1, 2000,
L6	and ending June 30, 2001\$ 1,073,755.00.
L7	SECTION 3. Of the funds appropriated in Section 2, the
L8	following amounts shall be derived from the Education Enhancement
L9	Fund as follows:
20	(a) Twenty-two Thousand Two Hundred Seven Dollars
21	(\$22,207.00) shall be derived from funds deposited
22	pursuant to Sections 27-65-75 and 27-67-31, Mississippi
23	Code of 1972.
24	(b) One Million Fifty-one Thousand Five Hundred
25	Forty-eight Dollars (\$1,051,548.00) shall be
26	derived from funds deposited pursuant to

- 27 Section 27-103-203(1), Mississippi Code of 1972.
- SECTION 4. No general funds authorized to be expended herein
- 29 shall be used to replace federal funds and/or other special funds
- 30 which are being used for salaries which are withdrawn and no
- 31 longer available.
- 32 SECTION 5. It is the intention of the Legislature that the
- 33 agency's budget request for Fiscal Year 2002 shall be submitted to
- 34 the Joint Legislative Budget Committee in a format and level of
- 35 detail comparable to the format and level of detail provided
- 36 during the Fiscal Year 2001 budget request process.
- 37 SECTION 6. Should revenues generated and deposited to the
- 38 Education Enhancement Fund pursuant to Section 27-103-203(1),
- 39 Mississippi Code of 1972, fall below funds appropriated herein
- 40 from said source, the Board of Trustees of State Institutions of
- 41 Higher Learning shall notify the Department of Finance and
- 42 Administration as to which allotments shall be reduced to insure
- 43 that expenditures do not exceed actual revenues.
- SECTION 7. It is the intention of the Legislature that of
- 45 the funds appropriated under the provisions of this act, the
- 46 amount of Two Hundred Thousand Dollars (\$200,000.00) shall be
- 47 allocated to defray the cost of a Sweet Potato program in Bolivar
- 48 County.
- 49 SECTION 8. The money herein appropriated shall be paid by
- 50 the State Treasurer out of any money in the State Treasury to the
- 51 credit of the proper fund or funds as set forth in this act, upon
- 52 warrants issued by the State Fiscal Officer; and the State Fiscal
- 53 Officer shall issue his warrants upon requisitions signed by the
- 54 proper person, officer or officers in the manner provided by law.
- 55 SECTION 9. This act shall take effect and be in force from
- 56 and after July 1, 2000.
