SENATE BILL NO. 3283
(As Sent to Governor)

1 AN ACT MAKING AN APPROPRIATION OF SPECIAL FUNDS FOR THE
2 SUPPORT OF THE STATE DEPARTMENT OF BANKING AND CONSUMER FINANCE
3 FOR FISCAL YEAR 2001.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 SECTION 1. The following sum of money, or so much thereof as
6 may be necessary, is hereby appropriated out of any money in the
7 State Treasury to the credit of the State Department of Banking
8 and Consumer Finance, for the support of the State Department of
9 Banking and Consumer Finance, for the fiscal year beginning
10 July 1, 2000, and ending June 30, 2001.....
11\$ 3,753,481.00.

12 SECTION 2. Of the funds appropriated under the provisions of
13 Section 1, not more than the amounts set forth below shall be
14 expended for the respective major objects or purposes of
15 expenditure:

32 With the funds herein appropriated, it is the intention of
33 the Legislature that it shall be the agency's responsibility to
34 make certain that funds required to be appropriated for "Personal
35 Services" for Fiscal Year 2002 do not exceed Fiscal Year 2001
36 funds appropriated for that purpose, unless programs or positions
37 are added to the agency's Fiscal Year 2002 budget by the
38 Mississippi Legislature. Based on data provided by the
39 Legislative Budget Office, the State Personnel Board shall
40 determine and publish the projected annual cost to fully fund all
41 appropriated positions in compliance with the provisions of this
42 act. It shall be the responsibility of the agency head to insure
43 that no single personnel action increases this projected annual
44 cost and/or the Fiscal Year 2001 appropriation for "Personal
45 Services" when annualized. If, at the end of any calendar month,
46 the State Personnel Board determines that the agency has taken
47 action(s) which would cause the agency to exceed this projected
48 annual cost or the Fiscal Year 2001 "Personal Services"
49 appropriated level, when annualized, then only those actions which
50 reduce the projected annual cost and/or the appropriation
51 requirement will be processed by the State Personnel Board until
52 such time as the requirements of this provision are met.

53 Any transfers or escalations shall be made in accordance with
54 the terms, conditions, and procedures established by law.

55 No general funds authorized to be expended herein shall be
56 used to replace federal funds and/or other special funds which are
57 being used for salaries authorized under the provisions of this
58 act and which are withdrawn and no longer available.

59 SECTION 3. Of the funds appropriated under the provisions of

60 Section 1 and allocated in Section 2, funds in the amount of One
61 Hundred Fifty-one Thousand One Hundred Eighty-eight Dollars
62 (\$151,188.00) and three (3) full-time positions are provided to
63 carry out the provisions of Senate Bill No. 3100, Regular Session
64 of 2000. In the event that Senate Bill No. 3100, Regular Session
65 of 2000, is not enacted into law, it is the intention of the
66 Legislature that the Department of Banking and Consumer Finance
67 shall not expend One Hundred Fifty-one Thousand One Hundred
68 Eighty-eight Dollars (\$151,188.00) of the funds appropriated under
69 the provisions of Section 1, nor shall the department fill more
70 than forty-one (41) of the full-time positions authorized in
71 Section 2 of this act.

72 SECTION 4. The money herein appropriated shall be paid by
73 the State Treasurer out of any money in the State Treasury to the
74 credit of the proper fund or funds as set forth in this act, upon
75 warrants issued by the State Fiscal Officer; and the State Fiscal
76 Officer shall issue his warrants upon requisitions signed by the
77 proper person, officer or officers in the manner provided by law.

78 SECTION 5. This act shall take effect and be in force from
79 and after July 1, 2000.
