31 With the funds herein appropriated, it is the intention of 32 the Legislature that it shall be the agency's responsibility to 33 make certain that funds required to be appropriated for "Personal 34 Services" for Fiscal Year 2002 do not exceed Fiscal Year 2001 35 funds appropriated for that purpose, unless programs or positions are added to the agency's Fiscal Year 2002 budget by the 36 Mississippi Legislature. Based on data provided by the 37 38 Legislative Budget Office, the State Personnel Board shall 39 determine and publish the projected annual cost to fully fund all appropriated positions in compliance with the provisions of this 40 It shall be the responsibility of the agency head to insure 41 act. 42 that no single personnel action increases this projected annual 43 cost and/or the Fiscal Year 2001 appropriation for "Personal Services" when annualized. If, at the end of any calendar month, 44 45 the State Personnel Board determines that the agency has taken action(s) which would cause the agency to exceed this projected 46 47 annual cost or the Fiscal Year 2001 "Personal Services" appropriated level, when annualized, then only those actions which 48 49 reduce the projected annual cost and/or the appropriation 50 requirement will be processed by the State Personnel Board until such time as the requirements of this provision are met. 51 52 Any transfers or escalations shall be made in accordance with 53 the terms, conditions, and procedures established by law. 54 No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are 55 56 being used for salaries authorized under the provisions of this 57 act and which are withdrawn and no longer available. SECTION 3. The money herein appropriated shall be paid by 58

60 credit of the proper fund or funds as set forth in this act, upon 61 warrants issued by the State Fiscal Officer; and the State Fiscal 62 Officer shall issue his warrants upon requisitions signed by the 63 proper person, officer or officers in the manner provided by law. 64 SECTION 4. This act shall take effect and be in force from 65 and after July 1, 2000.
